## What is the Office of Natural Resources Revenue (ONRR)?

ONRR is an office within the Office of the Secretary that is responsible for the management of revenues associated with federal offshore and federal and American Indian onshore mineral leases, as well as revenues received as a result of offshore renewable energy efforts. This revenue management effort is one of the federal government's greatest sources of non-tax revenues.

## What is the State and Indian Outreach Service?

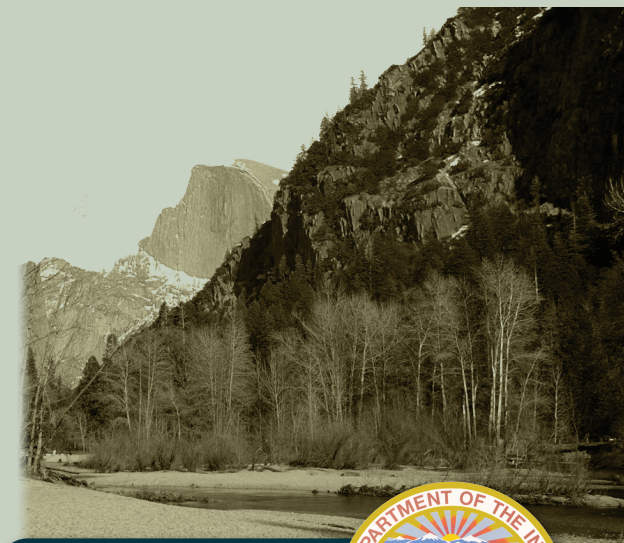
The State and Indian Coordination Office is a special organization within the Office of Natural Resources Revenue, which is specifically dedicated to serving mineral producing tribes and individual Indian mineral owners. A component of this organization is the State and Indian Outreach service which is designed to resolve royalty-related problems and to let individual owners know how to contact us. Regularly scheduled outreach meetings enable us to answer questions, listen to concerns and suggestions for improvement, and identify and resolve mineral-related problems in partnership with the Department of the Interior's Bureau of Indian Affairs, Bureau of Land Management, and Office of the Special Trustee for American Indians. We have an Oklahoma City office which services the State of Oklahoma, a Farmington office which services Navajo mineral owners, and a Denver office which services Colorado, Montana, North Dakota, Utah and Wyoming. Our goal is to enhance our trust responsibility and foster a positive working relationship with the Indian community.

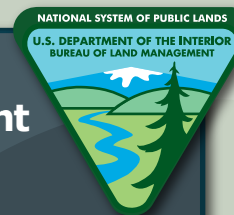

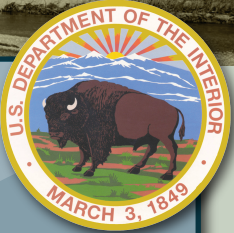
