

**U.S. Fish and Wildlife Service

Great Ape Conservation Fund FY2014**

In 2014, the USFWS awarded 32 new projects and one amendment to an existing cooperative agreement from the Great Ape Conservation Fund totaling \$1,951,602, which was matched by \$2,956,930 in additional leveraged funds. Field projects in 16 range countries in Africa and Asia (in alphabetical order below) will be supported, in addition to three projects that involve multiple countries.

**AFRICA**

In 2014, the USFWS provided funding to 13 projects and an amendment to one existing cooperative agreement for ape conservation in Africa, totaling \$993,427 in USFWS funding which was matched by an additional \$1,915,788 in leveraged funds. The funding supports field activities in nine African countries and three projects involving multiple countries in Africa.

*US Fish & Wildlife Service – WCS cooperative agreement: A landscape approach to conservation of the critically endangered Cross River gorilla.* In partnership with the Wildlife Conservation Society, this five-year cooperative agreement seeks to ensure the survival of the critically endangered Cross River gorilla through support to a network of core protected areas and corridors across the Afi Kagwene landscape in Nigeria and Cameroon managed in collaboration between local communities and government. Funds will enable continued support towards camera trapping, increased patrols and completion of the Cross River gorilla Action Plan.

*Increasing community conservation engagement in the proposed Ebo National Park, Cameroon.* In partnership with the Zoological Society of San Diego, the purpose of this project is to conserve the gorillas and chimpanzees of the future Ebo National Park by expanding community-led conservation initiatives, continuing monitoring and surveillance activities, facilitate study visits by local university students, and strengthening partnerships with regional stakeholders. This will be done by enhancing local support for chimpanzee and wildlife conservation, including through two established ‘Clubs des Amis des Gorilles’ (Gorilla Guardian

Clubs), with a third community that joined in late 2013; continuing detailed transect surveys and monitoring threats; and hosting a major field school at the Njuma field station to train and strengthen engagement with the newly-established Ebo-Chiefs Association, the Ministry of Forests and Wildlife (MINFOF), and other elites to develop Ebo into a National Park.

*Evaluating the impact of long-term field projects and anti-poaching patrols on local populations of bonobos: a bottom-up approach for evidence-based bonobo conservation.* In partnership with the Max Planck Institute for Evolutionary Anthropology, the purpose of this project is to evaluate the population density of bonobos and other wildlife and monitor the status of human encroachment activities. The information will be used to develop a conservation strategy for bonobos in a forest area of the buffer zone of Salonga National Park. This will be done by assessing the population density of bonobos and other wildlife in a region of about 500 km<sup>2</sup>, evaluating the frequency and nature of human encroachment within the 500 km<sup>2</sup> area, and modeling the impact of the long-term field project and anti-poaching patrol activities on the local bonobo population in order to develop an evidence-based conservation strategy.

*Protecting the chimpanzees of Mt. Hoyo through improved law enforcement.* In partnership with the Wildlife Conservation Society, the purpose of this project is to enhance security of chimpanzees in the Hoyo-Virunga landscape by establishing a patrol-based law enforcement system, identifying the current status and threats facing chimpanzees in the landscape, and educating communities about wildlife laws and the *Institut Congolais pour la Conservation de la Nature* (ICCN). This will be done by supporting existing patrols of 28 rangers at Mt. Hoyo; providing technical support and training to rangers and management staff; conducting a survey of chimpanzees (and other biodiversity) in Mt. Hoyo and the adjacent corridor; and increasing awareness among local communities regarding wildlife laws, the role of ICCN, and the conservation of chimpanzees.

*Wildlife law enforcement in Guinea – GALF (Guinée-Application de la Loi sur la Faune).* In partnership with the Wara Conservation Project, the purpose of this project is to assist the government of Guinea to increase wildlife law enforcement capacity, produce effective deterrents to the killing of elephants and other threatened wildlife, and monitor the illegal wildlife trade and other activities detrimental to ape survival. This will be done by identifying large-scale dealers in ivory and bushmeat and providing evidence to support legal action against them; bringing about the arrest and ensuring the prosecution of large-scale illegal wildlife

traders; and raising public awareness of the increased enforcement of wildlife law and the risks and penalties for wildlife criminals.

*Protection of the Parc National du Haut Niger - Republic of Guinea.* In partnership with the Pan African Sanctuary Alliance, the purpose of this project is to support the development of the Chimpanzee Conservation Center (CCC) by building capacity, strengthening local engagement, and conducting chimpanzee monitoring. This will be done by hiring a protection supervisor and training a local protection manager; ensuring the protection of the northern portion of the *Parc National du Haut Niger* (PNHN); continuing to promote coordination among government and park authorities to harmonize law enforcement efforts; ensuring that the newly trained PNHN eco-guards are strategically placed in and around the PNHN; and conducting a survey of the CCC release site in the PNHN with local and international partners to guide protection efforts.

*Improving West African chimpanzee conservation through protected area management in the proposed Grebo National Park.* In partnership with the Wild Chimpanzee Foundation, the purpose of this project is to protect chimpanzees in the proposed Grebo National Park (PGNP) by improving management capacity of chimpanzees and developing local community involvement in chimpanzee conservation. This will be done by re-training Forestry Development Authority (FDA) agents and local community members in biomonitoring (data collection); implementing and supervising FDA and community-led teams collecting data on chimpanzees and anthropogenic threats; training and supporting the FDA in biomonitoring data analysis and report preparation; re-training local community members to act as eco-guards for the PGNP; carrying out sensitization activities on the status of the PGNP; and creating and supporting micro-projects of alternative protein sources in local communities.

*Goualougo Triangle Ape Project: Empowering Congolese students to strengthen the link between applied research and conservation policy.* In partnership with the Wildlife Conservation Society, the purpose of this project is to improve the long-term conservation of great apes in the Republic of Congo by increasing local capacity and professional development. This will be done by providing advanced training in applied conservation research and facilitating opportunities for Goualougo Triangle Ape Project (GTAP) staff to link this information directly to conservation policy; promoting leadership of GTAP staff in great ape health monitoring initiatives (including training in new technologies for data collection and expansion of worker health programs); implementing a mentoring program which prepares research assistants to increase their

participation in local, regional and international conservation advocacy; and involving GTAP's research staff in enhanced surveillance and monitoring activities, such as Spatial Monitoring and Reporting Tool (SMART) to protect at-risk ape populations along the southeast border of the Nouabalé-Ndoki National Park.

## **RWANDA**

*Ensuring the continued growth of the Virunga mountain gorilla population through protection, monitoring and research.* In partnership with the Dian Fossey Gorilla Fund International, the purpose of this project is to protect mountain gorillas through continuing conservation and monitoring, collecting behavioral, health, and demographic data, and developing scientific capacity of Rwandan staff, scientists, and other collaborators. This will be done by ensuring daily physical presence among nine gorilla groups (120 individuals total) by accompanying each group with a team of three-four paramilitary trained trackers; collecting daily standardized health, demographic, and ranging data to guide veterinary and park management; conducting 75 independent anti-poaching patrols in the Karisoke sector of Volcanoes National Park; conducting 275 anti-poaching patrols alongside national park service staff; developing the scientific expertise of Rwandan research assistants in basic scientific methodologies; and building the capacity of undergraduate science managers in conjunction with the National University of Rwanda.

*Complete survey of chimpanzees outside of protected areas in Senegal: Filling gaps in our knowledge in anticipation of corporate mining development.* In partnership with Iowa State University, the purpose of this project is to understand the impacts of proposed large-scale mining and to identify key habitats for future protection in areas of southeastern Senegal. This will be done by determining the presence and relative densities of chimpanzees in these areas.

*Evaluating the efficacy of conservation drone technology for chimpanzee monitoring in western Tanzania.* In partnership with Liverpool John Moores University, the purpose of this project is to evaluate the efficacy of using conservation drones to monitor chimpanzee populations in western Tanzania. This will be done by comparing chimpanzee nest densities along the same transects using two different survey methods – ground and unmanned aerial vehicle (UAV) - and determining the costs associated with each method to evaluate which method will be most cost-effective for future monitoring.

This will be done by producing a series of radio serial dramas.

*Community-based conservation of eastern hoolock gibbon and its habitat in Karen State, phase III - Strengthening sustainabilities.* In partnership with the People Resources and Conservation

Foundation, the purpose of this project is to strengthen community forest management at three priority sites, specifically targeted at protecting globally significant populations of eastern hoolock gibbon. This will be done through various activities, including developing and carrying out participatory action plans to address threats to gibbons and local conservation values; supporting assisted habitat regeneration in gibbon habitat corridors; and carrying out systematic gibbon population inventories.

*Pileated gibbon conservation education and public outreach through the Kouprey Express.* In partnership with Wildlife Alliance, the purpose of this project is to deliver an education curriculum that includes information regarding wildlife and forestry laws and information that will enable Cambodians to make informed decisions regarding the sustainable management of their natural resources while promoting protection of areas rich in biodiversity. This will be done by delivering a gibbon-focused environmental education curriculum to students, teachers, community members, and community leaders in Koh Kong, Kompong Som, and Phnom Penh; conducting conservation-oriented Community Night Shows and field trips to Phnom Tamao Wildlife Rescue Center (PTWRC); conducting follow up visits to each school to ensure that teachers are delivering the environmental education lessons and to provide them continuing support in doing that; expanding the Kouprey Express' partnership network; and renewing existing signs and installing new, high visibility multi-lingual billboards and overhead signs at highly trafficked intersections with conservation messages targeting illegal trafficking of wildlife.

*Enhanced conservation of yellow-cheeked crested gibbon through direct protection and ecotourism in southern Monduliri, Cambodia.* In partnership with the Wildlife Conservation Society, the purpose of this project is to ensure the long-term conservation of the largest population of the yellow-cheeked crested gibbon in the world through effective protection of the core area of Seima Protection Forest and the development gibbon-based ecotourism. This will be done by direct protection of gibbons and their habitat; monitoring of law enforcement efforts using Spatial Monitoring and Reporting Tool (SMART) conservation software; developing a community-based ecotourism project; and monitoring key indicators of the ecotourism project.

This will be done by developing a monitoring protocol; identifying areas of high gibbon density and their preferred habitat; determining the feasibility of

undertaking a joint approach to long term gibbon monitoring and conservation with the park's major concession holder and the national park's management; and improving national capacity to undertake gibbon conservation.

This will be done by continuing regular patrols according to Spatial Monitoring and Reporting Tool (SMART) protocols; systematically recording patrol details and using this information to plan future patrols; training the gibbon patrol units; and working with the Police Department and/or Army to provide the patrol teams with additional law enforcement training.

This will be done by providing nearly 100 Forest Guards training on a range of topics, including gibbon survey techniques and gibbon conservation.

*Monitoring and protection of reintroduced orangutans in the Batikap Hill Conservation Forest, Central Kalimantan, Indonesia.* In partnership with Yayasan Penyelamatan Orangutan Borneo (BOS Foundation), the purpose of this project is to support the successful reintroduction of rescued orangutans into well-protected natural forest in synergy with local community engagement and support, thus creating a long-lasting legacy for nature conservation and poverty eradication. This will be done by monitoring released orangutans and providing on-site veterinary support; undertaking weekly visits to nearby villages; establishing a human-orangutan conflict mitigation plan; developing an environmental education program; assisting villages to implement their community development plan; and developing and implementing a regular conservation patrol plan in partnership with the local government.

*Saving Sumatran orangutans through improving and strengthening law enforcement.* In partnership with the Wildlife Conservation Society, the purpose of this project is to reduce poaching, illegal logging, encroachment, and other threats in key-habitat in Gunung Leuser National Park as well as trade, trafficking and possession of Sumatran orangutans. This will be done by patrolling key orangutan habitats in Gunung Leuser National Park; and enabling the collection of information on illegal trade in orangutans in order to capture, arrest and successfully prosecute poachers and traders of orangutans.

*Saving rainforests and endangered species through health care and alternative livelihood training.* In partnership with Health in Harmony, the purpose of this project is to conserve Gunung Palung National Park, an important protected area for orangutans and gibbons through a program that uses health care benefits as an incentive for villagers to stop illegal logging. This will be done by carrying out low-cost reforestation of orangutan corridors; conducting a “Turn Your Debt to Forest” campaign; developing alternative livelihoods for people engaged in illegal logging; expanding the illegal logging monitoring program; and developing a How-to Manual for replication in other locations.

*Improving the conservation status of western black crested gibbon in Nam Kan National Protected Area, Lao PDR.* In partnership with Fauna and Flora International, the purpose of this project is to improve the understanding of the status of the black crested gibbon (*Nomascus concolor*) in Nam Kan National Protected Area (NPA), to support management planning and prioritize resources for the conservation of the species. This will be done by providing the necessary training to local government and non-government organization staff and then carrying out field surveys of the gibbons throughout the NPA; assessing threats to gibbons through village interviews; conducting a village awareness program; engaging stakeholders to prepare a Species Conservation Action Plan and find a solution to NPA conservation and management hindered by an ambiguous boundary demarcation; and facilitating the implementation of effective law enforcement patrols through provision of Spatial Monitoring and Reporting Tool (SMART) training to the village law enforcement patrol teams.

*Strengthening systems for reducing poaching and forest encroachment, and law enforcement monitoring for gibbons in Nam Kading National Protected Area, Lao PDR.* In partnership with the Wildlife Conservation Society, the purpose of this project is to strengthen defenses against poaching and habitat encroachment for globally significant gibbon populations in the Nam



Kading National Protected Area by increasing enforcement staffing; expanding the coverage of patrols and investigations; forming a mobile rapid response team for investigating and suppressing wildlife crime; and implementing the new improved SMART system for law enforcement monitoring.

This will be done by conducting district meetings to increase cooperation between the relevant government agencies and patrol teams; supporting substation heads to attend the monthly strategic planning meetings to create adaptive, strategic plans for protecting gibbons and to report on findings from patrols; and increasing and strengthening forest-based patrolling.

*Assessing orangutan density with unmanned aerial vehicles: testing a new method along the Kinabatangan river, Sabah, Malaysia.* In partnership with Liverpool John Moores University, the purpose of this project is to conduct a set of aerial (unmanned aerial vehicle, or UAV, and helicopter) and ground surveys so that it can be determined whether the UAV surveys can provide similar density estimates as those from ground and helicopter surveys and whether a fully automated system to detect nests can be used to assess orangutan status not only in Kinabatangan, but throughout Borneo. This will be done by comparing nest density results obtained in the same forest patches using three different survey methods and the costs associated with each method; determining the usage of non-forest land by orangutans in the Lower Kinabatangan Wildlife Sanctuary (LKWS); determine the LKWS areas that need regular monitoring; and developing models of the habitat changes in those same areas so the changes may be assessed and their impacts upon orangutan movements may be determined.

*Conservation of orangutans in the Batang Lemanak-Batang Skrang area of Lanjak-Entimau Wildlife Sanctuary (LEWS) and in the Ulu Sungai Menyang area in Sarawak, Malaysia.* In partnership with the Wildlife Conservation Society, the purpose of this project is to increase the level of legal protection and rates of detection and reporting of wildlife crimes through outreach and education to local people and by involving them in conservation activities. This will be done by conducting community dialogue and engagement; conducting biological surveys and creating a spatial overlay of orangutan nest encounters for the landscape; organizing meetings with Sarawak Forestry Corporation (SFC) and other potential partners to revise the current

conservation outreach program; co-developing, implementing and evaluating orangutan-themed skits with SFC based on the storyline of previously developed radio programs; and conducting community dialogues.

*Strengthening conservation of the northern yellow-cheeked gibbon and the establishment of community-based monitoring groups on the eastern slope of the Central Annamites, Vietnam.* In partnership with the Southern Institute of Ecology in Vietnam, the purpose of this project is to provide accurate information on the status of the gibbons of this region, encourage involvement of local people in gibbon monitoring and conservation, and facilitate establishment of new protected areas in the region. This will be done by establishing community-based monitoring and patrol teams; providing training on survey techniques; estimating the population size of gibbons and identifying key sites for conservation of gibbons and other endangered primates; providing training on identification of globally threatened and most commonly traded species in the region; and conducting an awareness-raising program in secondary schools and villages in two districts.

*Benefit sharing access and the conservation of the yellow-cheeked crested gibbons within Vietnam's Bu Gia Map National Park.* In partnership with Bu Gia Map National Park, the purpose of this project is to better protect the habitats of the yellow-cheeked crested gibbon within the protected area by limiting the impacts of local people on the park's core zone and by creating benefit sharing mechanisms within the park. This will be done by conducting focus groups to identify harvested non-timber forest products and creating a map of the areas that can be harvested without disturbing the gibbons or damaging their habitats; monitoring the harvestable species to ensure sustainability; formalizing agreements for the purpose of benefit sharing; creating non-timber forest management councils to help control and monitor activities within the park; and using sign boards to create borders between the preferred habitats of the gibbons and harvestable areas.

*Mitigating threats to the western black crested gibbon in northern Vietnam via community conservation teams and enforcement of firearm controls.* In partnership with Fauna and Flora International, the purpose of this project is to reduce anthropogenic resource extraction from the Muong La Watershed Area and Mu Cang Chai Species Habitat Conservation Area to halt habitat loss and stabilize the western black crested gibbon population. This will be done by strengthening community-based protection of the gibbons and their habitat; strengthening enforcement of the national firearm decree to curtail illegal hunting; and constructing a forest conservation station to allow more strategic patrolling.

This will be done by strengthening enforcement on wildlife crimes; strengthening regulation and management of private zoos and living collections of endangered wildlife; generating intelligence for monitoring key wildlife networks; and strengthening capacity of frontline enforcement officers.
