15th MEETING OF THE CONFERENCE OF THE PARTIES TO CITES

Results of Proposals to Amend the CITES Appendices I and II at CoP15 May 28, 2010

The tables below indicate the results of the species proposals to amend Appendices I and II, as adopted by the Conference of the Parties (CoP) to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) at its fifteenth regular meeting (CoP15).

The meeting was held in Doha, Qatar, March 13-25, 2010. Forty-two proposals to amend the Appendices were submitted for discussion at this meeting. Links to the original proposals are provided in the table below.

Amendments made to the Appendices at CoP15 enter into effect on June 23, 2010, and the <u>CITES Appendices</u> will be updated to reflect these changes. Unless otherwise noted in the Appendices, all CITES listings cover live and dead specimens, and all parts and derivatives.

The CITES Secretariat has also published the following two documents regarding the amendments to the Appendices made at CoP15:

- a) seeds (including seedpods of Orchidaceae), spores and pollen (including pollinia). The exemption does not apply to seeds from Cactaceae spp. exported from Mexico, and to seeds from *Beccariophoenix madagascariensis* and *Neodypsis decaryi* exported from Madagascar;
- b) seedlings or tissue cultures obtained in vitro, in solid or liquid media, transported in sterile containers;
- c) cut flowers of artificially propagated plants;
- d) fruits and parts and derivatives thereof of naturalized or artificially propagated plants of the genera Vanilla (Orchidaceae), and of the family Cactaceae.;
- e) stems, flowers, and parts and derivatives thereof of naturalized or artificially propagated plants of the genera *Opuntia* subgenus *Opuntia* and *Selenicereus* (Cactaceae); and
- f) finished products of Euphorbia antisyphilitica packaged and ready for retail trade."

Footnote 6 was amended as follows:

- "Artificially propagated specimens of the following hybrids and/or cultivars are not subject to the provisions of the Convention:
- Hatiora x graeseri
- Schlumbergera x buckleyi
- Schlumbergera russelliana x Schlumbergera truncata
- Schlumbergera orssichiana x Schlumbergera truncata
- Schlumbergera opuntioides x Schlumbergera truncata
- Schlumbergera truncata (cultivars)
- Cactaceae spp. colour mutants grafted on the following grafting stocks: Harrisia 'Jusbertii', Hylocereus trigonus or Hylocereus undatus''
