A.) Background:

Since the enactment of the Personal Responsibility and Reconciliation Act of 1996, the results within the first three years show that welfare caseloads have declined by 54% and 4.7 million Americans have moved from welfare dependency to self-sufficiency. In light of this, President George W. Bush is calling on Congress to sustain and expand on the success of welfare reform. The President's plan is designed to strengthen families and help more welfare recipients work toward independence and self reliance. The Walgreen Company, located in suburban Chicago, has been in support of this initiative since its involvement in 1997 when it participated with 50 of the nation's largest corporations. Together they agreed to form the Welfare to Work Partnership, which would promote the efforts of corporations to train and hire welfare recipients. As Walgreens continues to grow as a company, now operating over 4,000 stores in 43 states across the Nation, it allows more opportunities for qualified people to become Walgreen employees and be given a chance to advance within the store's career ladder.

Given the training and employment needs of public housing residents, the **Insert Name of Housing Authority**, in addition to implementing a welfare to work program, is seeking to establish collaborations with for profit and non-profit organizations that will facilitate the transition of residents from unemployment to gainful employment.
