# Subject: Changes in Financial Management and Reporting Requirements for Public Housing Agencies Under the New Operating Fund Rule (24 CFR Part 990); Interim Instructions

## 1. Purpose.

This notice transmits changes in financial management and reporting requirements for public housing agencies (PHAs) pursuant to the Revisions to the Public Housing Operating Fund Program, Final Rule (hereafter referred to as the "final rule") published in the <u>Federal Register</u> on September 19, 2005 (79 FR 54983). The final rule replaces the interim rule that was published on March 29, 2001.

#### 2. Background.

The final rule requires that PHAs of 250 or more units convert to project-based budgeting and accounting. PIH Notice 2005-34, issued November 2, 2005, established the following schedule for compliance with these new project-based budgeting and accounting requirements:

- For PHAs wth fiscal years beginning July 1, the initial compliance year is the PHA fiscal year July 1, 2007 June 30, 2008.
- For October 1 PHAs, the initial compliance year is the PHA fiscal year October 1, 2007 September 30, 2008.
- For January 1 PHAs, the initial compliance year is the PHA fiscal year January 1, 2008 December 31, 2008.
- For April 1 PHAs, the initial compliance year is the PHA fiscal year April 1, 2008 March 31, 2009.

This notice provides instructions to PHAs on the changes in financial management and reporting requirements related to project-based budgeting and accounting pursuant to the final rule.

Handbook 7475.1 REV., CHG-1, Financial Management Handbook, is in the process of being revised and the information included in this supplement will be included in the forthcoming revision of Handbook 7475.1. The information and instructions found in the attached supplement are considered program requirements.

# 3. <u>Applicability</u>.

This notice applies to all PHAs that operate public housing. As indicated in the attached supplement, PHAs with fewer than 250 public housing units will be less affected by the changes in financial reporting as a result of public housing's transition to asset management.

#### 4. Comments.

This notice is being issued as interim instructions. Because of the nature of the changes included, the Department is inviting comments from interested parties. All comments are due no later than 60 days after the issued date shown on this notice. The Department will then reissue this notice taking into account the comments received.
