States Earn Nearly \$1.32 Billion in Federal Mineral Receipts

WASHINGTON – The Department of the Interior’s Office of Natural Resources Revenue (ONRR) announced today that nearly \$1.32 billion was disbursed to 37 states, as well as counties and political subdivisions as part of the State share of Federal revenues collected in Fiscal Year 2016 from energy and solid mineral production that occurred on Federal lands within their borders and offshore on the Outer Continental Shelf.

2: Included in the State disbursements is \$3,229,359 disbursed to 35 counties in eight states from geothermal energy production.
