### **Changing a Child Support Order in Your State**

### The information below applies only to Kentucky

#### 1. How can I find out if I have a "IV-D" child support case in this state?

The parent may contact the Kentucky Child Support Hotline toll free at (800) 248-1163.

### 2. How can I contact my child support agency?

You may access the Kentucky Child Support Interactive website at http://csws.chfs.ky.gov/csws/. The website has a "Locate Office" feature to select a county and provides contact information for the county selected. Parents with an existing case may select the "My Account" option and register for a customer service account. Once the registration process is complete, the parent can access his/her case account information online.

### 3. If I am incarcerated, are there any barriers to having my order changed?

Yes, Kentucky Child Support policy prohibits local child support offices from filing actions to review and/or modify a support obligation of a parent when the basis for the review is incarceration. If the parent files his/her own motion with the Court to modify the support obligation, the local child support office should contest the modification and request the Court to deny the modification on the basis that the noncustodial parent's reduction in income is voluntary.

### **6.** When can I ask to have my order changed?

A parent may request a review when there is a change of circumstances that would warrant a change in the child support obligation. However, after conducting the review the local child support office may determine that the case does not meet the criteria for modification.

### 7. How do I request the change?

To initiate a review, a parent must submit a written request to their local child support office. The written request should include the parent's name, the other party's name, the name of the children, IV-D case number if available, and the reason for requesting the review.

## 8. What is the process after I've asked to have my order changed, and how long does it take?

After the local child support office receives the review request, the worker sends a modification packet to the parties and/or other forms to the employer to gather income and other financial information to calculate the child support obligation. Upon receiving the information necessary to calculate the child support obligation, the child support worker calculates the support using the Kentucky Child Support Guidelines. If the review reflects the case does not meet the criteria for a modification, the worker sends notice to the parties explaining why the case is not eligible for modification. If the review reflects the case does meet the criteria for a modification, the worker attempts to resolve the matter by agreement of the parties to prevent filing a motion with the court or proceeds with filing a motion with the court. The process from beginning to end generally takes six months; however, if the case must be heard by the court, this process could take longer.

9. Is this process different if the other parent agrees to the change in advance?

Yes, if both parents are willing to enter into an agreed order to modify the support obligation, most Kentucky Courts do not require a motion to be filed with the court. Most Kentucky Courts allow the parties to sign an agreed order which is then submitted to the judge for approval and signature. This expedites the modification process and eliminates the need to file a motion with the court and conduct a hearing before a judge.
