My dear Mr. Hirsch:

Last year when I was in Washington I asked for the 1810 census for the Illinois district of Indiana Territory and was informed that the records were missing from your files. I am enclosing two copies of the Illinois district for 1810. Several years ago when I started to edit our Illinois State Census returns for 1818 and 1820 Dr. Theodore C. Pease of the Illinois Historical Survey at the University of Illinois sent me some notes taken in connection with such an edition started under the late Dr. Alvord but not completed. Among these notes was a carbon copy of this 1810 federal census. Neither Dr. Pease nor I have ever been able to find any trace of the first typewritten copy or of the original from which it was taken, and Dr. Pease has been unable to find out how this carbon copy got into his files. It is a copy of this which I now send you. There are some obvious misreadings from the original text, but I have not altered them, not having seen the original. I promised you a copy of these schedules some time ago, but until now have been unable to fulfil my promise.
