### DISSERTATION

The dissertation uses Talcott Parsons as an influential case of a scientist promoting the institutionalization of the “nature/nurture” controversy and dichotomy in American sociology and science more broadly. It shows that Parsons severely omitted the body from his theory in the 1930s only to reintroduce it in the late 1950s because he had over-responded to two things. In the 1930s he believed sociology’s institutionalization was tenuous and threatened by biological reductions coming from economics and behaviorism. He understood the expansiveness of his theorizing as the way to secure sociology, but also as the way to secure his own position at Harvard and to live up to the standards of the many “big thinkers” there. These several factors explain both Parsons’s taking up the “nurture” side of the nature/nurture dichotomy and the ambitiousness of his theoretical project and vision for sociology.
