Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Pre-Lab Quizzes (100 points) – Before starting each laboratory exercise you will be given a short quiz (~10 min) to assess how well prepared you are for that day's lab by reading the background information and procedures covered in the manual. Each quiz will be worth 5 points.

Lab Exercise Completion (100 points) – Once you complete each lab exercise, at the end of the lab session, the instructor will sign off your lab manual. Each lab exercise completion will be worth 5 points.

Laboratory Practical Exams (200 points) – Two exams will be given and they will consist of a combination of short answer and fill in the blank questions that require identification and mastery of lab topics, materials and equipment, as presented in the lab manual and discussed during the lab sessions.
