Personal Campus Safety Tips

- Always be aware of your surroundings
- Avoid walking alone at night (safety in numbers)
- Avoid poorly lit and isolated areas
- Carry a personal alarm or whistle
- Avoid wearing expensive jewelry, accessories
- Keep your cell phone with you
- Do not leave expensive personal items unattended
- Keep an emergency/first aid kit in your vehicle
- Immediately report suspicious persons and behavior

Parking on the UNT Dallas Campus

All UNT Dallas students and employees are required to purchase and properly display a current parking permit on the vehicle they own or park on campus. A limited number of pay meters (which do not require a permit) may be available. Pay meters are enforced. Visitors are allowed to park free, but may be required to obtain a visitor permit from the Visitor Kiosk or the Police Department. Visiting guests and family members of UNT Dallas student and employees are required to adhere to the parking guidelines for visitors. Buying Parking Permits Online

Students, faculty and staff may purchase parking permits online for the Dallas campus.

1. Go to: www.unt.edu/transit/
2. Click on *Buy Permits and Manage Account*
3. Log in using your EUID and password

You will be able to print out a temporary permit to place on your dashboard until your permanent permit arrives by U.S. mail.

You must be a declared UNT Dallas student, faculty or staff member to purchase a UNT Dallas Parking Permit.

Jeanne Clery Act

In accordance with the Jeanne Clery Disclosure of Campus Security Policy and Crimes Statistics Act (Clery Act), the University of North Texas at Dallas makes its annual report available to all students and other interested parties. Duty to report Child Abuse

Section 261.101 of the Texas Family Code requires that “A person having cause to believe that a child’s physical or mental health or welfare has been adversely affected by abuse or neglect by any person shall immediately make a report...”. Incidents of observed or suspected child abuse occurring on campus should immediately be reported to the UNT Dallas Police Department at 972.780.3009 or 972.780.3000.

Racial Profiling Prohibited

Racial profiling is prohibited by law. Accordingly, the University of North Texas at Dallas Police Department has an established policy prohibiting racial profiling. Complaints against UNT Dallas police officers for this or other behaviors will be investigated in a confidential, courteous, and efficient manner.

Emergency Preparedness

- Emergency Procedures (placards and flip charts) are strategically located throughout campus and in all classrooms
- Always be aware of your surroundings
- Immediately report suspicious persons and behavior
- Familiarize yourself with escape routes, exits, and stairwells
- In the event of an active shooter, armed intruder, or similar emergency, be prepared to run, hide or fight (view the *Run, Hide, Fight* video on the police department’s website, dallas.unt.edu/police)
- For severe weather/tornado response: seek the lowest level of the building you are in – offices, rooms, stairwells, as far away from glass as possible
- Ensure you are subscribed to the campus’ mass notification system (JAGAlert)
- Always carry your cell phone with you
- Know the locations of campus emergency telephones (Blue Telephones) located throughout the campus and parking lots
- Evacuate at least 50’ from buildings for smoke and fire alarms
- Evacuate 300’ from buildings for bomb threats, bombs, and explosions
