Pohl Recreation Center Spring 2016 Executive Summary

The dates of this report are January 2 – May 14, 2016. This time period begins with the first day of Rec Center spring reduced hours (January 2), and ends with the final day of spring reduced hours (May 14).

262,139 participations

- o This counts each participant as many times as they used the facility.
- This is a 12.18% (28,458) increase in participations compared with spring 2015 (233,681).

• 15,840 individual participants

o This number indicates that 15,840 people used the facility 262,139 times.

15,036 individual students

- This counts every enrolled student that used the facility. This number is subtracted from the individual participants above.
 - This indicates that 804 of the individual participants were not UNT students.
 - 43% of all UNT students used the Rec Center.

Student Characteristics

- Of the 15,036 student users, 13,023 are enrolled full time and 2,013 are enrolled part time.
 - 51% of full-time UNT students used the Rec Center.
 - 21% of part-time UNT students used the Rec Center.
- o 7,828 student users are male (52%), and 7,208 are female (48%).
 - University of North Texas Student profile: 16,505 are male (47%), and 18,534 are female (53%).
- 70% of all Freshmen used the Rec Center, 58% of all Sophomores used the Rec Center, 43% of all Juniors used the Rec Center, and 37% of all Seniors used the Rec Center.
- o 59% of First Time In College students used the Rec Center.

Ethnicity of Student Users

- 43% of the student users were Caucasian, 16% of the student users were African-American, 23% of the student users were Hispanic, 8% of the student users were Asian American.
 - The facility had a higher percentage of African American, Hispanic, and Asian American students than UNT enrollment.
 - The facility had a lower percentage of Caucasian and American Indian students than UNT enrollment.

• Residence of Student Users

- o 30% of student users live in a Residence Hall, 20% live in Denton City, 8% live in Denton County (outside of Denton City) and 42% live outside of Denton County.
 - 76% of all UNT students who live in Residence Halls use the Rec Center.
 - 49% of all UNT students who live in Denton City use the Rec Center

• GPA of Student Users-

 This compares the average GPA of the facilities' student users to the average GPA of the University non users. For each classification level, the GPA of Rec Center users was higher than non-users.

Freshmen: 2.69 Users, 2.47 Non-Users
Sophomores: 2.86 Users, 2.65 Non-Users
Juniors: 2.92 Users, 2.81 Non-Users

Seniors: 3.08 Users, 3.02 Non-Users
