

# 2019 Entry Agreement Best American Newspaper Narrative Contest

Sponsored by The Dallas Morning News

By entering this contest, I hereby agree that should my previously-published newspaper narrative be judged as one of the winners of the Mayborn's Best American Newspaper Narrative Writing Contest (the "Contest"), meaning being designated as the first, second, or third place winner or one of the three runners-up or one of the four notable narratives, then upon announcement of the prize, I shall grant non-exclusive publication rights in print and e-book form to the Frank W. Mayborn Graduate Institute of Journalism/UNT Press, in order to publish in print and e-book form an anthology of the winning entries. Copyright to the piece is NOT transferred to Mayborn/UNT Press; only a grant of rights to publication is required.

### Both Page Two and Page Three of this entry form must be filled out, signed and returned with the entry to enter the contest.

I warrant that the narrative is an original work of mine, has been previously published in a newspaper **between Jan. 1 and Dec. 31, 2018**, and that I either possess the sole and exclusive authority to grant the publishing rights to the story or have obtained a release from the original publisher granting me those print and e-book publication rights.

There is a \$50 fee per entry. An entry may be a single story or a series. Entry fees may be paid by credit card online at <a href="http://www.themayborn.com/bann">http://www.themayborn.com/bann</a>. If my previously-published narrative is <u>NOT</u> judged one of the winners (first, second, or third place or one of three runners-up or one of four notable narratives), then I and or my publisher retain publication rights to my manuscript and Page Three of this entry form is **NOT** in effect.

#### RELEASE FOR PUBLICATION

This Release provides for the publication of an Author's contribution named below (the "Contribution"), to be included in **Best American Newspaper Narratives Volume 6** ("Work") co-published by the University of North Texas Press and the Mayborn School of Journalism (the "Publisher"). The Contribution, an excerpt of the Contribution, or an edited version of the Contribution, may also be loaded online for open access, included in any republication of the Work, in any publication or republication of the Work in alternate format or media, and/or in any other manner as deemed appropriate in the sole discretion of the Publisher.

1.	GRANT OF RIGHTS. Author grants to Publisher the right to print and/or publish, electronically or
	otherwise, including open access; market; and sell (including the right to permit others to publish and
	sell) the Contribution in the English language and throughout the world, including the following
	subsidiary rights to the Contribution: book clubs; reprint editions by another publisher; translation
	into foreign languages; selections into anthologies, compilations, and digests; omnibus volumes;
	microform, duplication, or photocopying; and the right of reproduction and/or storage of a portion of
	Work by electronic or other mechanical means and devices. Said Contribution is:

- **2. COPYRIGHT.** Author retains copyright in his or her name for the Contribution and is free to republish the Contribution elsewhere in any form of publication.
- 3. WARRANTY. Author warrants that the Contribution is an original work of Author; that Author possesses the sole and exclusive authority to enter into this Agreement and to provide the warranties and grant the rights as set forth herein; and that the Contribution contains no matter that is libelous or otherwise unlawful or that invades individual privacy or infringes any proprietary right or any statutory copyright. Author agrees to indemnify, defend and hold the Publisher and the University of North Texas ("UNT"), the University of North Texas System ("System"), as well as Publisher's and the System's Board of Regents, officers, employees, agents, students, successors, licensees, and assigns, and any seller of the Contribution or Work, harmless against any claims, demands, suits, losses, liabilities, and costs, including but not limited to attorneys' fees and amounts paid in settlement, arising out of or connected in any way with the publication or sale of the Contribution or any alleged breach of the terms or conditions of this Agreement by Author, including but not limited to any breach of warranty.
- **4. REMUNERATION**. In consideration for entering into this Agreement, Publisher shall provide to Author as total remuneration to be received, one free copy of the Work containing the Contribution. Author may purchase additional copies of the Work by direct order to the Publisher at a discount of 40 percent from the then-prevailing list price. It is understood and agreed that Author shall not be entitled to and shall not make any claim for any royalties or any remuneration other than as set forth herein in regard to the publication of the Contribution.
