- A. Faculty Academic Workload recommendation (*Dr. Iftexhar Amin, Faculty Alliance Vice-Chair*)

Suggestions for Teaching Load Paradigms

Tenured or Tenure-Track: *Tenure Line faculty have two possible options:*

a) Teaching/Research Track

b) Teaching/Service Track

Features of the Teaching/Research Track: *3x3 teaching load (60% teaching; 30% research; 10% service). Faculty who select this track must attain excellence in research (e.g., one peer-reviewed publication per year) and teaching, as defined by the university. Faculty on this track must meet expectations in service. Faculty must apply for permission to be on this track on an annual basis. The application will include a description of the research plan, the presumed impact of the research, and intended targets for dissemination/distribution.*

Features of the Teaching/Service Track: *4x4 teaching load (80% teaching; 10% research; 10% service). Faculty on this track must attain excellence in teaching and either service or research (and must meet expectations in the third category), depending on the focus/emphasis of the individual faculty member. The 80% allocation toward teaching is mandatory, but the remaining 20% is variable in terms of areas of focus, and can be distributed flexibly from year-to-year, depending on the faculty member's interests (and/or departmental needs) in a given annual timeframe.*

Lecturer Line

Features of the Lecturer Line: 4x4 teaching load (80% teaching; 20% service). Lecturers are service leaders on campus in comparison to tenure lines. All Lecturers must attain service and teaching excellence, as defined by the university.

Other Suggestions:

1) In an academic year, each course instructed counts 10% toward faculty workload. This percentage is consistent across job categories.

2) Tenure-track faculty apply for the line they desire, and it is approved by the School Dean (in consultation with program coordinators/chairs).

3) Tenure-line faculty may apply to be moved to different tracks (within their own job category).

4) The School Dean is the ultimate authority in determining workload distribution. However, program coordinators/chairs have the power to make suggestions for each full-time faculty member's yearly workload, based on consultations between the coordinator/chair and each faculty member to determine the faculty member's yearly goals, desires, intentions, etc., in combination with departmental needs and standards of the discipline.

5) Workload accrued from the instruction of science labs will be credited through the following formula: 1 classroom contact hour = .66 workload credit hours (UNT-Denton standard).

6) Program Coordinators/Chairs receive one course release for every semester of service (contingent upon Dean's approval).

7) The University, School, and/or Deans reserve the right to vary the paradigms above based on departmental needs and/or extraordinary administrative service to the university, school, or profession.
