

To receive the Environmental Volunteerism Graduation Cord (EVGC) through the LLELA (Lewisville Lake Environmental Learning Area) Track, you must complete this Self-Tracking form with 75 or more volunteer hours at LLELA and meet the requirements below. Once you complete and submit this Self-Tracking Form via email, you must fill out a completion survey about your volunteer experiences before collecting your graduation cord. The completion survey will be sent to you via email if your recorded hours meet the requirements for the cord. After these steps, you will receive your cord and have the opportunity to apply to the LLELA Restoration Intern Program.

If you plan to apply to the LLELA Restoration Intern Program, it is advised to complete the 75 volunteer hours earlier in your degree plan to be able to participate in the intern program while still a UNT Student.

- All volunteer efforts must be environmentally focused
- Reported volunteer efforts must not be considered as class requirements, course credit, employment, nor court ordered community service
- Monetary compensation must not be accepted for volunteer efforts
- · Hours must be completed during your time as a student at UNT
