STUDENTS WILL HAVE THE CHOICE TO TAKE REGULAR EXAMS IN PERSON AT SAGE HALL ON THE UNT DENTON CAMPUS OR REMOTELY. STUDENTS WHO OPT TO TAKE THE EXAMS REMOTELY WILL BE REQUIRED TO MAKE ARRANGEMENTS AT THEIR OWN EXPENSE TO EITHER TAKE THE EXAM AT A LIVE PROCTORING SITE (SUCH AS A SYLVAN LOCATION OR A COMMUNITY COLLEGE WHICH OFFERS THE SERVICE) OR BY PROCTOR U REVIEW+ PROCTORING SERVICE. THE REVIEW+ SERVICE COSTS APPROXIMATELY \$30-\$40 PER EXAM. STUDENTS WHO TAKE THE EXAM IN PERSON AT SAGE HALL CAN DO SO WITH NO ADDITIONAL CHARGES.
