**PURPOSE:** The purpose of this program is to provide tuition rebates that will provide a financial incentive for students to prepare for university studies while completing their high school work, avail themselves of academic counseling, make early career decisions, and complete their baccalaureate studies with as few courses outside the degree plan as possible. Minimizing the number of courses taken by students results in financial savings to students, parents, and the state.

The University of North Texas notifies all students of the tuition rebate program through notice in the university catalog and in its graduation materials. If requested by potentially eligible students who have early registered and meet all course requirements, UNT will provide opportunities to enroll during each fall and spring semester in the equivalent of at least 12-semester credit hours that apply toward their degrees. *UNT is not required to provide students with the opportunity to enroll in specific courses or special sections.*

***Rebate checks and correspondence are mailed to the student Mailing Address provided and maintained by the student at <http://my.unt.edu>.*** If a student is found to be ineligible for a rebate a statement explaining why the student is ineligible will be provided. UNT will provide a dispute resolution process to resolve issues related to local administration of the program. Eligible students will receive rebated tuition within 60 days after graduation.

**Please read the below acknowledgements. By signing below, you indicate your understanding of these statements:**

- I understand that students with more than 3-hours of credit with grades of “F”, “W”, “WF”, “NP”, “I”, or “Z” from any institution attended are ineligible to receive the \$1000 Tuition Rebate.
- I have enrolled for the first time in an institution of higher education in the fall 1997 semester or later.
- I am requesting a rebate for coursework related to a first baccalaureate degree received from a general academic teaching institution.
- I have been a resident of Texas and have been entitled to pay resident tuition at all times while pursuing my degree.
- I have attempted no more than three hours in excess of the minimum number of semester credit hours required to complete my degree under the catalog which I am graduating. *Hours attempted include transfer credits, course credit earned exclusively by examination (except that, for the purposes of this program, only the number of semester credit hours earned exclusively by examination in excess of nine semester credit hours is treated as hours attempted), courses dropped after the official census date, for-credit developmental courses, optional internship and cooperative education courses, and repeated courses. Courses earned prior to high school graduation as well as courses dropped for reasons that are determined by the institution to be totally beyond the control of the student shall not be counted.*
- I understand that it is my responsibility to notify UNT of my intention to apply for the tuition rebate prior to graduation and maintain my UNT mailing address.
- I understand that the tuition rebate for which I am applying will be applied to any student loans (including emergency loans) that I have not yet repaid.
- I understand that the tuition to be rebated to a student under this program is \$1,000 unless the total amount of undergraduate tuition paid by the student to UNT was less than \$1,000, in which event the amount of tuition to be rebated is an amount equal to the amount of undergraduate tuition paid by the student.
- **If enrolled for the first time in fall 2005 or later**, graduate within four calendar years for a four-year degree or within five calendar years for a five-year degree if the degree is in a program determined by the Texas Higher Education Coordinating Board to require more than four years to complete. In addition, an otherwise eligible student who enrolled for the first time in fall 2005 may be eligible for a tuition rebate without meeting the time-to-graduate limitations if the student is awarded a baccalaureate degree and the institution determines that the student’s failure to complete was caused by a demonstrated hardship condition.
