CONSTITUTION OF THE MULTICULTURAL GREEK COUNCIL OF THE UNIVERSITY OF NORTH TEXAS

PREAMBLE

Organizations based on cultural affinity provide important context for individuals to create friendships, serve the community, develop leadership and engage in the pursuit of knowledge. The Multicultural Greek Council unites organizations with a cultural and social emphasis in a mission of advancing collective fraternal values.

- Article I Name: The name of this organization shall be the Multicultural Greek Council of the University of North Texas, hereinafter referred to as MGC.
- Article II Purpose: The purpose of the MGC shall include, but not limited to, the following:
 - Section 1. To serve as a forum to advance important relationships developed through common meaningful experiences and based on progressing the purpose and the ideals of member organizations.
 - Section 2. To assist organizations in the accomplishments of fraternal goals.
 - Section 3. To provide services, resources, programs and activities to aid in the development of individuals engaged in culturally-based organizations at the University of North Texas.
 - Section 4. To support the mission of the University of North Texas and to complement other organizations invested in advancing the fraternity and sorority community in its entirety.
- Article III Membership: Any social Greek-letter organization affiliated with a national/international organization and is recognized as such by the University of North Texas may hold membership in the MGC.
- Article IV Organizational Structure: The MGC shall consist of the legislative body, executive board, and other committees, as deemed necessary to achieve the purpose of the MGC.
 - Section 1: Legislative body
 - a. Shall consist of one official representative from each fraternity or sorority.
 - b. Each official representative shall have one (1) vote.

- c. A quorum shall consist of two-thirds (2/3) of the legislative body and if only minimum quorum is met all votes must be unanimous.
- Section 2: Officers: The officers of the MGC shall be outlined in the bylaws
- Section 3: Executive Board
 - a. The executive board shall be charged with the responsibility of directing the day to day functions of the MGC.
 - b. Membership in the executive board shall be outlined in the Bylaws.
 - c. The executive board may exercise one (1) additional vote in case of a tie.
- Section 4: Meetings: The MGC shall meet regularly during the school years as prescribed in the Bylaws
- Section 5: Advisor: The University advisor to the MGC shall be the Assistant Dean of Students whose primary responsibility is fraternities and sororities.
- Article V Amendments to the Constitution: This Constitution may be amended by a two-thirds (2/3) vote at any regular meeting. Notice of a vote to amend this Constitution must be given in writing at least one meeting prior to the vote.
- Article VI Ratification: This Constitution shall be ratified by two-thirds (2/3) of its voting members. This constitution shall become effective immediately upon its ratification.
