PROJECT DESCRIPTION

- This project will consolidate, relocated and realign the College of Visual Art 7 Design's ceramics program and graduate studies in a new facility on the UNT campus at 1001 W. Mulberry Street, Denton, TX 76201.
- Relocation & reorganization is required to improve the learning experience & support an evolving pedagogy within the ceramics program.
- The Art Studio Facility and kiln yard is a new one story masonry building and enclosed outdoor kiln yard of approximately 25,242sf that will house instructional spaces, critique space, graduate studios, fabrication technology space, and ceramics specific manufacturing spaces/kiln yard.
- Part of the project is the coordination of relocating the Ceramics department from Oak Street Hall and the demolition of Oak Street Hall.
- Projected schedule is to have contract complete by February 2021 with potential start date in February 2021.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.



Why we do a HUB Subcontracting Plan (HSP)

- Texas State Law.
 - •Government Code Chapter §2161.252
 - Administrative Code §20.14
- •Demonstrates a "Good Faith Effort" (GFE) to diversify business opportunities.
- Responses that do not include a complete HSP must be rejected
