

Senior Agency Official for Records Management 2017 Annual Report

The <u>OMB/NARA *Managing Government Records Directive* (M-12-18)</u> requires Senior Agency Officials for Records Management (SAORM) to provide an annual report to NARA. NARA uses the reports to determine the overall progress of the Federal Government in meeting the goals of the *Directive* transitioning to electronic recordkeeping. NARA intends to list any non-responding agencies in a summary report and on the website.
