In a letter dated May 27, 2011, and received on July 15, 2011, the Board reported to ASC staff that this appraiser was allowed to renew during the late filing period because of a regulation which allows an applicant to be renewed during the 60-day late filing period with a penalty. Regulation 2309.5 states the following: A holder of a license who fails to renew before the expiration date may renew the license within sixty (60) days after expiration upon paying the required late fee. Upon renewal, the holder shall be deemed to have possessed a valid license and its renewal.
