The collateral security for Federal Reserve notes issued consists of \$14,279,000,000 in gold certificates and in credits with the Treasurer of the United States payable in gold certificates, \$10,800,000,000 face amount of United States Government securities and \$169,508,000 face amount of commercial paper. Notes issued by a Federal Reserve Bank are a first lien against the assets of such bank.
