**Action:** The secretariat will draft an announcement of BSR implementation date

## **BSR** Training materials

**Decision:** The SCT will make sure that the revised BIBCO training materials are simplified and not so focused on teaching cataloging. Those working on brief training sessions for the BSR should continue work (Magda and Iris Wolley; Robert Ellett is working on a live online Elluminate BSR session, the recording of this session can be shared). The group supported the development of an FAQ on the BSR.

**Status:** The FAQ has been posted on the BIBCO web site.

#### **BSR** for other formats:

The Standing Committee on Standards is asked to develop these, with advice from Jay Weitz about the stakeholder organizations for the other formats.

**Status:** The SCS has identified a number of stakeholder communities to contact for help developing other format standards.

# **MODS/Dublin Core Task Group Report**

**Action:** A charge will be written for a group to develop a standard record type list of elements that should be included in records created in other metadata formats.

Who: Adolfo, Carolyn, Les, Phil, Cynthia will draft a charge for PoCo approval.

## Low producers

NACO: Carolyn outlined the process used to contact low producers: offer additional help or ask if they still wish to be listed as NACO members.

SACO: Problem: there are a small number of participants who regularly submit proposals do not follow the rules and guidelines. Coop staff spend an inordinate amount of time resolving these issues.

Proposed solution: Provide mandatory remedial training for these participants with the stipulation that their work afterwards will be monitored for compliance. If there is still a problem after training, a decision could fairly be made to ask them not to contribute.

**Action:** Coop are investigating approaches for policy and training to accomplish the proposal.
