## Removed Records

In accordance with the Freedom of Information Act (FOIA), records have been removed prior to producing this document in accordance with the following Freedom of Information Act exemptions:

- Pursuant to Exemption Three, OSTP removed 1 entry because the individuals satisfied the requirements of one of the following statutes: (1) 50 U.S.C. § 3507;<sup>1</sup> (2) 50 U.S.C. § 3024(m)(1);<sup>2</sup>
  (3) 10 U.S.C. § 424;<sup>3</sup> and (4) 50 U.S.C. § 3605.<sup>4</sup>
- Pursuant to Exemption Six, OSTP redacted 2 entries because the individuals were either: (1) minor children at the time of the visit; or (2) interviewing for a position that they did not receive;<sup>5</sup> or (3) contained information regarding room numbers.
