Removed records

In accordance with the Freedom of Information Act, records have been removed prior to producing this document in accordance with the following Freedom of Information Act (FOIA) exemptions:

- Pursuant to Exemption Three, OSTP removed 9 entries because the individuals satisfied the requirements of one of the following statutes: 1) 50 U.S.C. § 3507; 2) 50 U.S.C. § 3024(m)(1); 3) 10 U.S.C. § 424; and 4) 50 U.S.C. § 3605.4
- Pursuant to Exemption Six, OSTP removed 1 entry because the individuals were either: (1) minor children at the time of the visit; or (2) were interviewing for a position that they did not receive.⁵
