- This tutorial provides general guidance on the features of the Actuarial Information Browser (AIB). The AIB allows users to see reports on actuarial data (such as commodities, rates, prices, and maps).
- After completing this tutorial, you will be able to:
 - ▣ Select a reinsurance year
 - ▣ Select your criteria and change the order of selection criteria
 - ▣ View maps with the Grid ID Tool
 - ▣ Clear data and view reports
 - ▣ Navigate via breadcrumb links
 - ▣ Show / hide the selection criteria to view more report information

Using this set of dropdown lists provides access to Crops, Livestock, and Rainfall & Vegetation Index offer information. This allows you to find Apiculture, for example, in a single list rather than requiring you to know that the Apiculture commodity is offered under the Rainfall Index, which has a fast path link on the left-hand navigation pane.

Clicking the Grid ID Tool link displays a map for the selected criteria.

Changing the order of your selection criteria allows you to decide how to filter the information you want to see.

Type numbers in the order you want the criteria to display and press **Tab** or click outside of the text box to trigger the reordering..


