SUBJECT: Theater Business Clearance/Contract Administration Delegation Update -Integration of TBC with the Joint Contingency Contracting System Platform

This memo sets forth an immediate requirement for DoD Contracting Officers to use the JCCS Platform's TBC Module to submit TBC requests for proposed contract efforts in the designated TBC countries: Afghanistan, Iraq, Kuwait and Pakistan (see reference (a)), and announces online and webinar training.

The aggressive rollout of this platform is imperative to provide visibility and control of the flow of contracted support into theater, especially in Afghanistan. To assist this rollout, training support efforts are planned to introduce the TBC module and to reiterate TBC policy and procedures. TBC/CAD:

- Helps create a common operating picture of contracted support in theater;
- Ensures solicitations and contracts contain appropriate local clauses and provisions;
- Assures contractor personnel life support requirements are addressed and coordinated prior to their arrival in theater; and,
- Ensures coordination of contract administration support in theater prior to contract award.

Access to JCCS and the associated TBC module requires creation of a JCCS Account. JCCS can be accessed from <u>https://www.jccs.gov</u>. Training on the TBC/CAD process and on using the JCCS Platform's new TBC Module will be offered to DoD Contracting Personnel via webinars based on the attached schedule, which also contains additional information and

guidance regarding these webinars. Contracting Officers are requested to review slides available at <u>http://www.acq.osd.mil/dpap/pacc/cc/index.html</u> (see Hot Topics) and apply for a JCCS account, prior to attending the webinar. TBC training modules for the Contracting Function, TBC Manager, and TBC Agent roles can be accessed 24/7 via the TBC Training Link located on the JCCS Training website at <u>https://www.jccs.gov/OLVR</u>. Additionally, TBC Job Aids have been developed to support users' daily business operations and can be found on the same JCCS TBC Training Link. If you have any additional TBC application questions, concerns, or issues, please contact the TBC Help Desk at jccs.support@dla.mil.

As noted in reference (b), TBC approval is required before initiating Letters of Authorization in SPOT for contractor personnel that will deploy into theater. The JCCS digitized TBC module streamlines the process, provides an electronic interface between JCCS and SPOT, enhances electronic storage, reporting and notifications, and generates machine generated standard TBC approval numbers. Moreover, it provides a standardized web-based TBC tool that all Combatant Commands can use to manage future TBC requirements.

Please forward this memo to your contracting activities immediately and have them report their compliance with the requirement to use the TBC Module by August 31, 2012.
