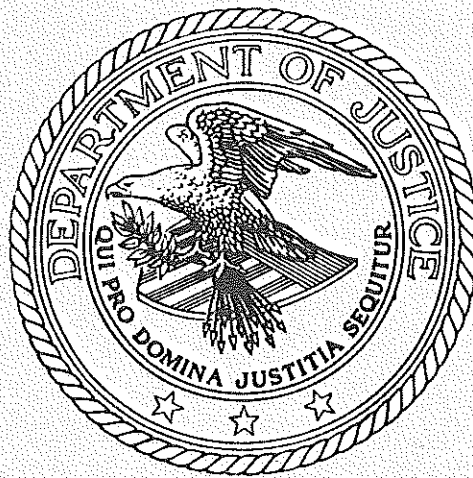

WORK HANDLED BY UNITED STATES ATTORNEYS' OFFICES
DURING FISCAL YEAR 1969

CRIMINAL CASES

FILED - Criminal filings amounting to 36,837 showed an increase of 4,309 or 13.2 per cent from the number filed in the previous fiscal year. About 73.1 per cent of the total was in 15 offenses having 700 or more cases; 11 showed increases while 4 showed decreases. The largest increases occurred in Bank Robbery (1169 to 1438), Counterfeiting and Forgery (1936 to 1964), Selective Service (1754 to 3436), Narcotics (3018 to 3634), National Motor Vehicle Act (4272 to 4417) and Income Tax dropped from 684 to 613. Increases took place in 56 districts ranging from 1 in Arkansas Eastern and Western to 788 in California Southern. Decreases took place in 36 districts ranging from 1 in Delaware to 210 in North Carolina Eastern.

TERMINATED - Cases terminated increased 2,652 or 8.5 per cent over the previous year's total. Of the total of 33,613 closed, 20,847 involving 25,207 defendants were pleas of guilty, 3,239 (involving 4,243 defendants) were found guilty after trial and 918 (involving 1,447 defendants) were found not guilty (including not guilty verdicts by reason of insanity.)

PENDING - With 20,504 cases, the pending caseload showed an increase of 18.6 per cent over the 17,280* cases pending at the close of fiscal year 1968. Of the pending cases, 10,253 cases were awaiting arraignment in court or trial, while 2,377 were awaiting court decision or sentence. 3,431 were in a fugitive or other status beyond the control of the United States Attorney.

GRAND JURY PROCEEDINGS

Grand Jury proceedings, comprised of 22,209 indictments and 356 No True Bills, amounted to 22,565 an increase of 19.4 per cent over the previous fiscal year.

CRIMINAL COMPLAINTS

RECEIVED - Complaints received increased to 135,602; this is 6.4 per cent more than the 127,366 received in fiscal year 1968. California Central with 8,461 had the most complaints and New York Eastern with 5,893 and District of Columbia with 5,679 were the next highest. 88,708 of the complaints were in eleven offenses as shown below:

PENDING - Criminal Complaints pending as of June 30, 1969 rose to 25,514 an increase of 3,062 or 13.6 per cent over the 22,452 pending as of June 30, 1968.

CIVIL CASES

FILED - Civil cases filed amounted to 25,100 an increase of 73 or .29 per cent more than the previous year's total. 48 districts had increases and 23 districts showed decreases from the previous year. 10,344 or 41.2 per cent of the total was in Fourteen districts having filings ranging from 523 to 1129. Tax Lien cases with 3,505 Tort cases with 2,088 and General Claims cases with 2,972 had 13.9 8.3 and 11.8 per cent respectively of the cases filed.

TERMINATED - With 47 Districts showing decreases and 46 Districts with increases, civil cases terminated increased to 24,604. This total is over fiscal year 1968's total by 98 or .40 per cent.

1,700 of these cases were suits in which the government as defendants was sued for \$188,588,155. 928 of them involving \$87,169,153 were closed by compromises amounting to \$10,542,294 and 376 involving \$50,006,508 resulting in judgments against the government amounting to \$11,198,898. The remaining 396 cases involving \$51,412,494 were won by the government, thus bringing the savings to \$166,846,963, an increase of \$56,682,971 or 51.4 per cent from the \$110,163,992 saved in Fiscal Year 1968.

PENDING - Civil cases pending as of the close of the fiscal year increased by 496 or 2.0 per cent to 25,094. 10,238 or 40.8 per cent of the caseload was in twelve districts with caseloads ranging from 610 in Ohio Southern to 1581 in New York Southern. Tax Lien cases with 3,732 decreased to 14.9 per cent of the total as compared to 3,981 or 16.7 per cent of the total pending as of June 30, 1968. Land cases with 1,849 or 7.4 per cent decreased from 1,850 or 7.5 per cent of the total.

CIVIL MATTERS

RECEIVED - Civil Matters received amounted to 31,234, an increase of 991 or 3.2 per cent more than the 30,243 in Fiscal Year 1968. Tax Lien matters with 3,548 and Tort matters with 2,288 comprised 11.3 per cent and 7.3 per cent respectively of the total. Delegated General Claims matters amounted to 5,065 or 16.2 per cent of the total. 8,858 or 28.4 per cent of the total was in eight districts having totals ranging from 815 in Illinois Northern to 1,348 in New York Southern.

TERMINATED - Civil matters terminated without reaching court dockets amounted to 5,310 a decrease of 22.2 or 1,514 from the fiscal year 1968 total of 6,824.

PENDING - 8,962 civil matters were pending as of June 30, 1968 as compared to 8,086 as of June 30, 1968. This is an increase of 876 or 10.8 per cent.

MAN-HOURS

A total of 207,348 man-hours were spent in court during Fiscal Year 1969. This is a decline of 6,402 or 3.0 per cent over Fiscal Year 1968. Following is a breakdown of those hours:

Based on an average employment of 676.4 each Assistant United States Attorney averaged 30.7 hours per month in courtroom working during the fiscal year. This compares with an averaged 30.9 hours per month in Fiscal Year 1968.

COLLECTIONS

Collections for Fiscal Year 1969 amounted to \$60,433,871, an increase of \$2,479,856 or 4.3 per cent over the \$57,954,015 collected in Fiscal Year 1968. This year's amount represents a return of \$2.46 for each dollar of the \$24,493,000 appropriated for United States Attorneys' Offices for the year ending June 30, 1969.

PERSONNEL

During the year United States Attorneys' employment averaged 1,827 employees, 396 employees were appointed and 564 were separated, a net decrease of 178 and 1,744 were on the rolls as of June 30, 1969. Cases handled per Assistant United States Attorney increased from 140.3 in Fiscal Year 1968 to 153.5 in the current year while cases terminated increased from 80.2 to 86.1.

CHART NO. 1 CASES PENDING IN UNITED STATES ATTORNEYS' OFFICES

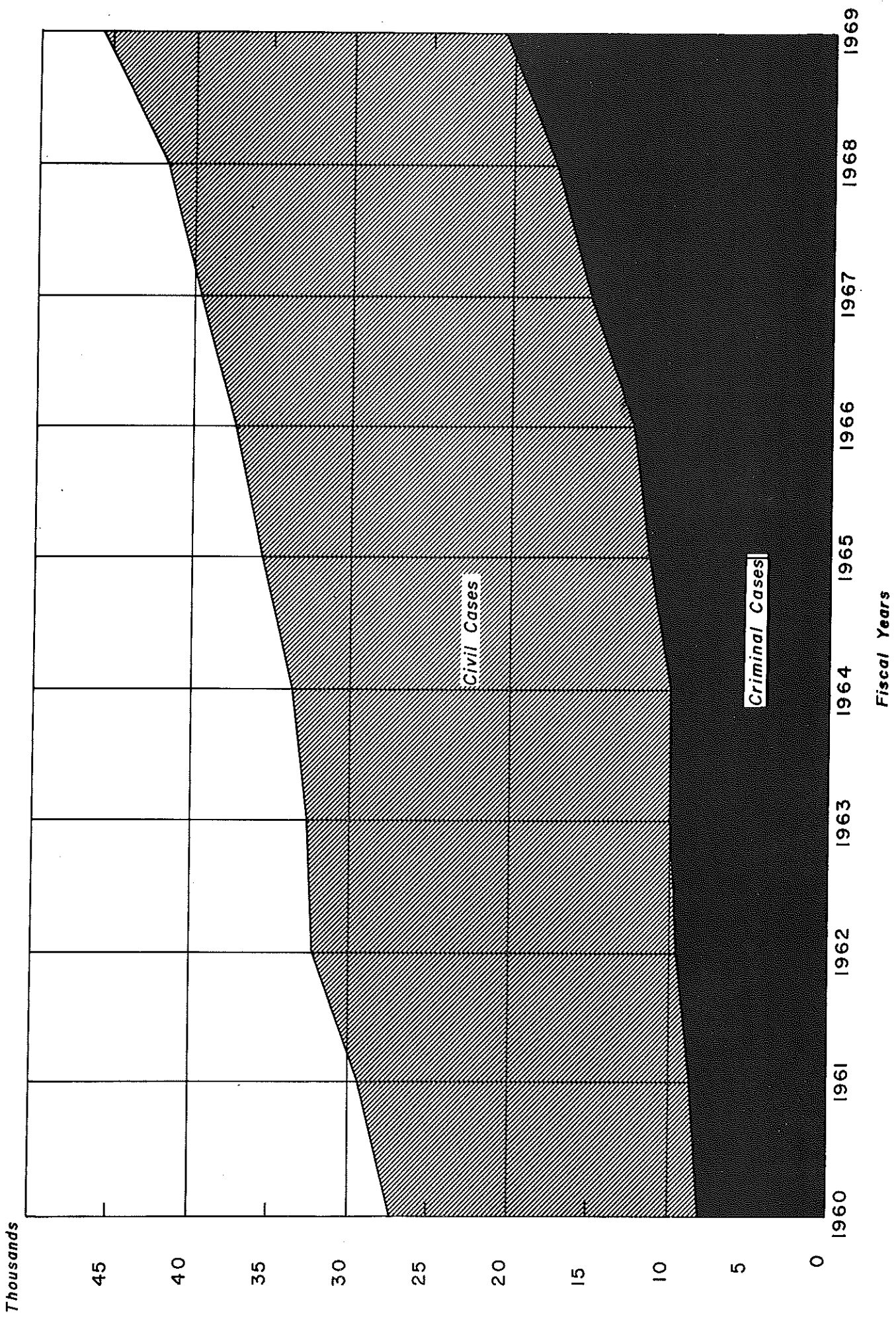


CHART NO. 2 CRIMINAL AND CIVIL CASES FILED IN UNITED STATES ATTORNEYS' OFFICES

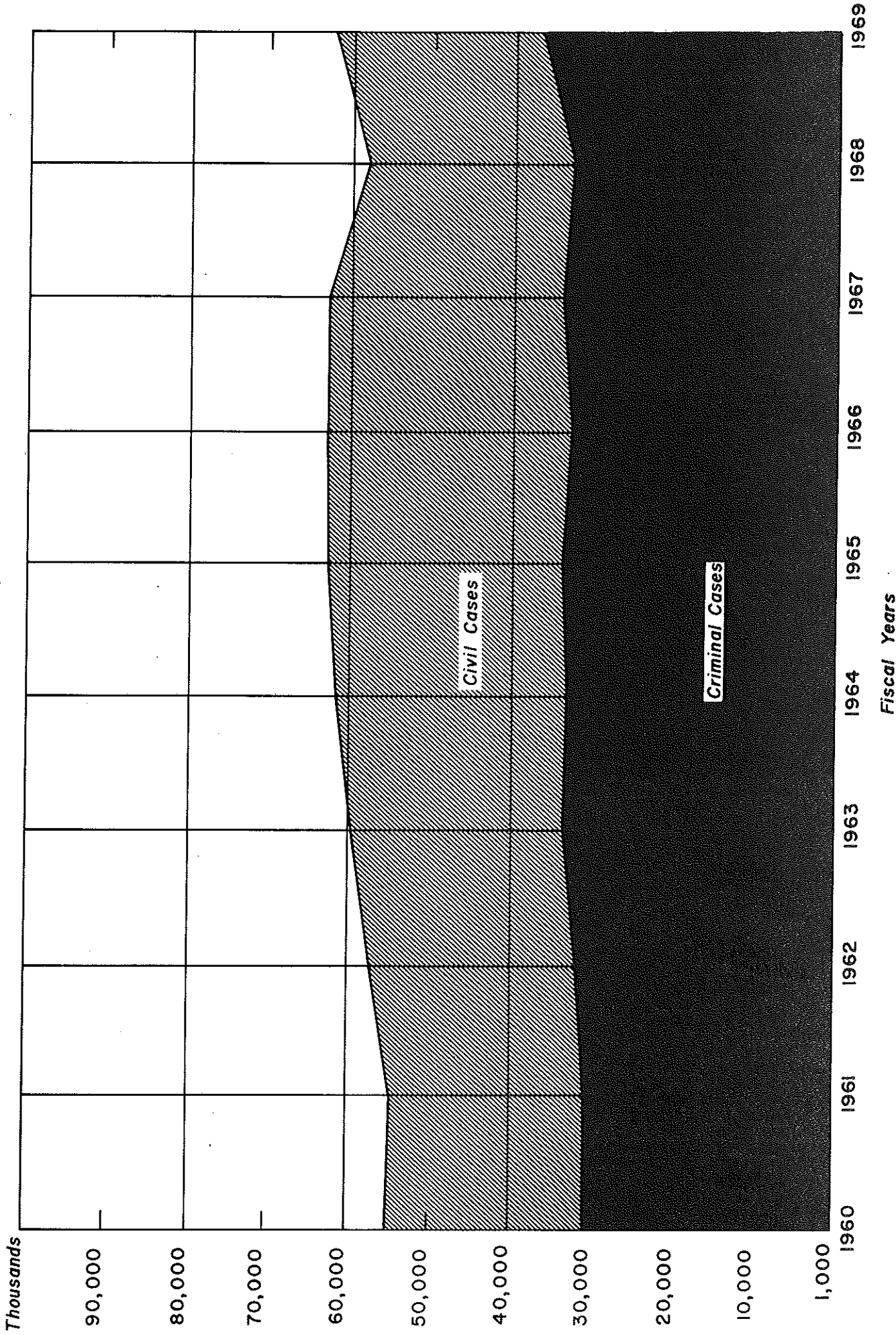

CRIMINAL AND CIVIL CASES TERMINATED IN UNITED STATES ATTORNEYS' OFFICES

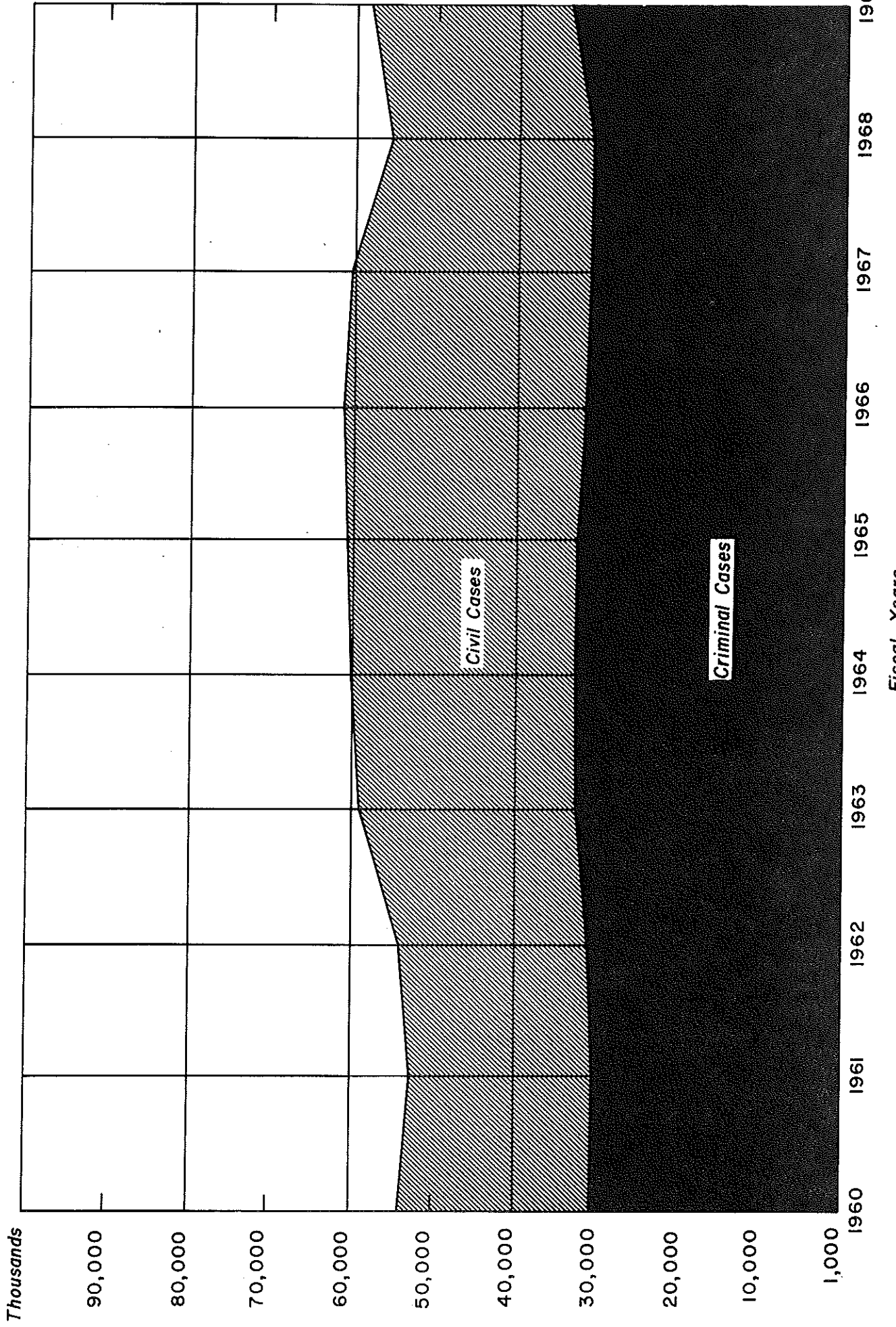


CHART NO. 4 CRIMINAL AND CIVIL MATTERS RECEIVED IN UNITED STATES ATTORNEYS' OFFICES

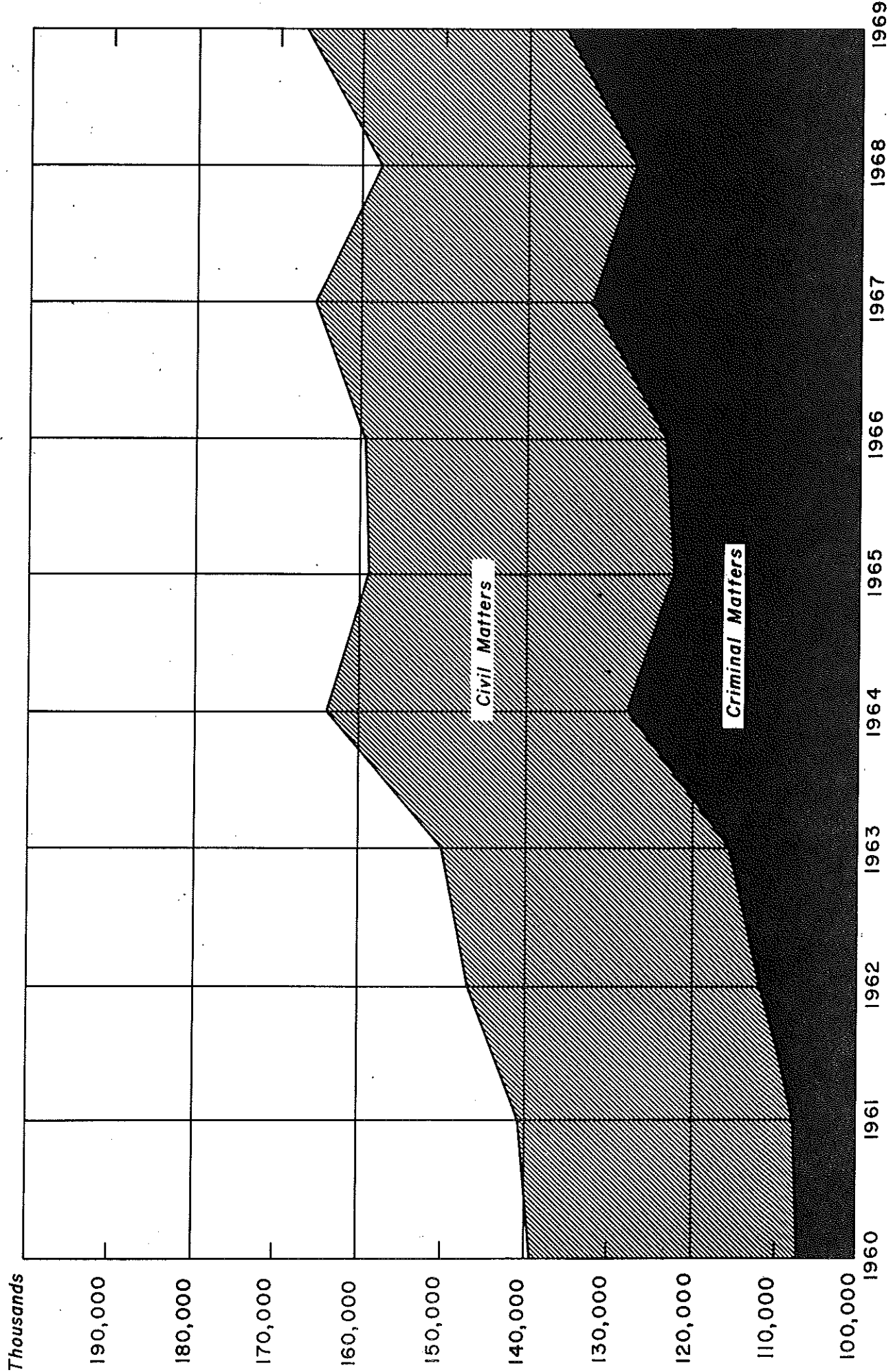

TRIALS IN CRIMINAL AND CIVIL CASES IN UNITED STATES ATTORNEYS' OFFICES

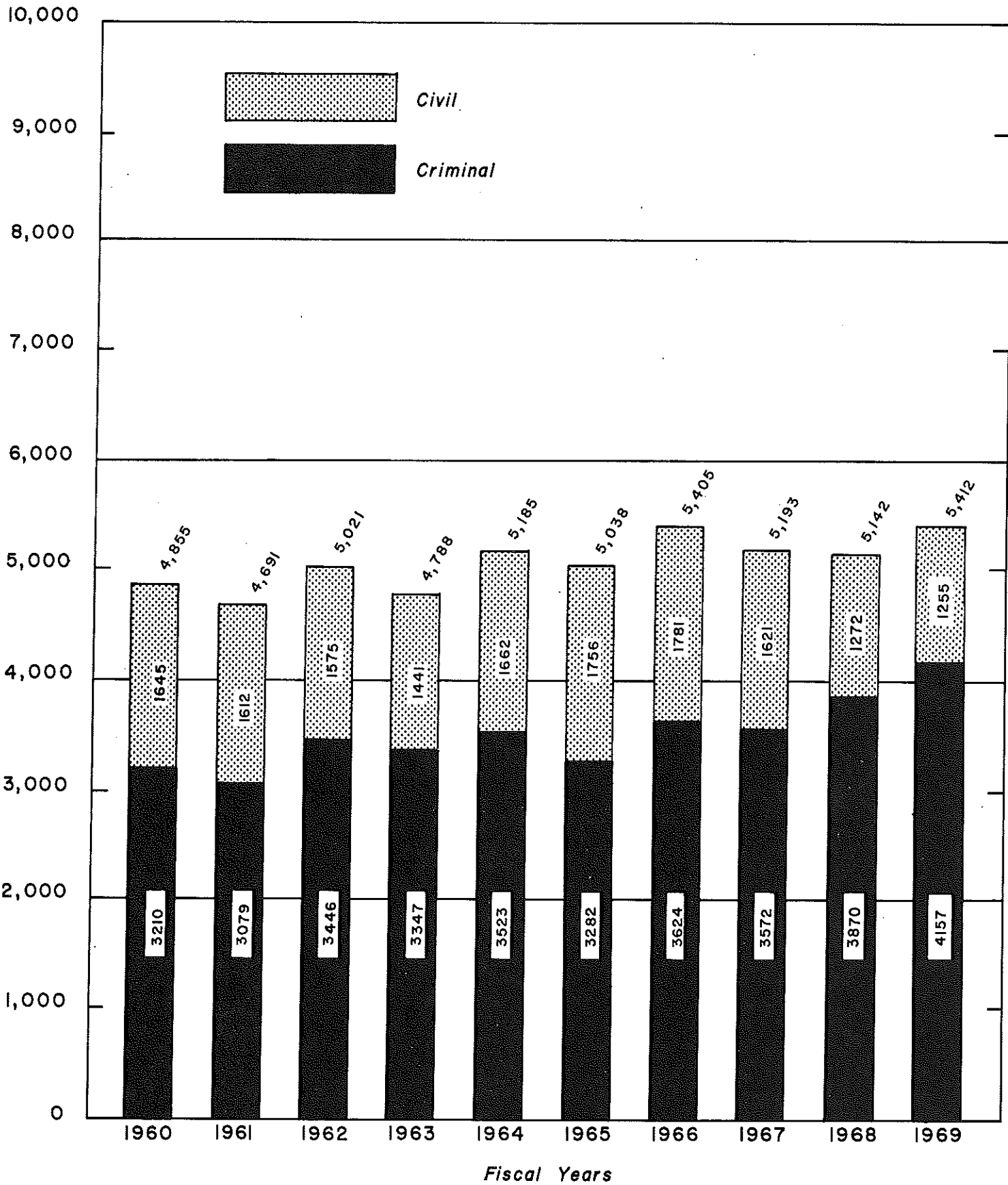

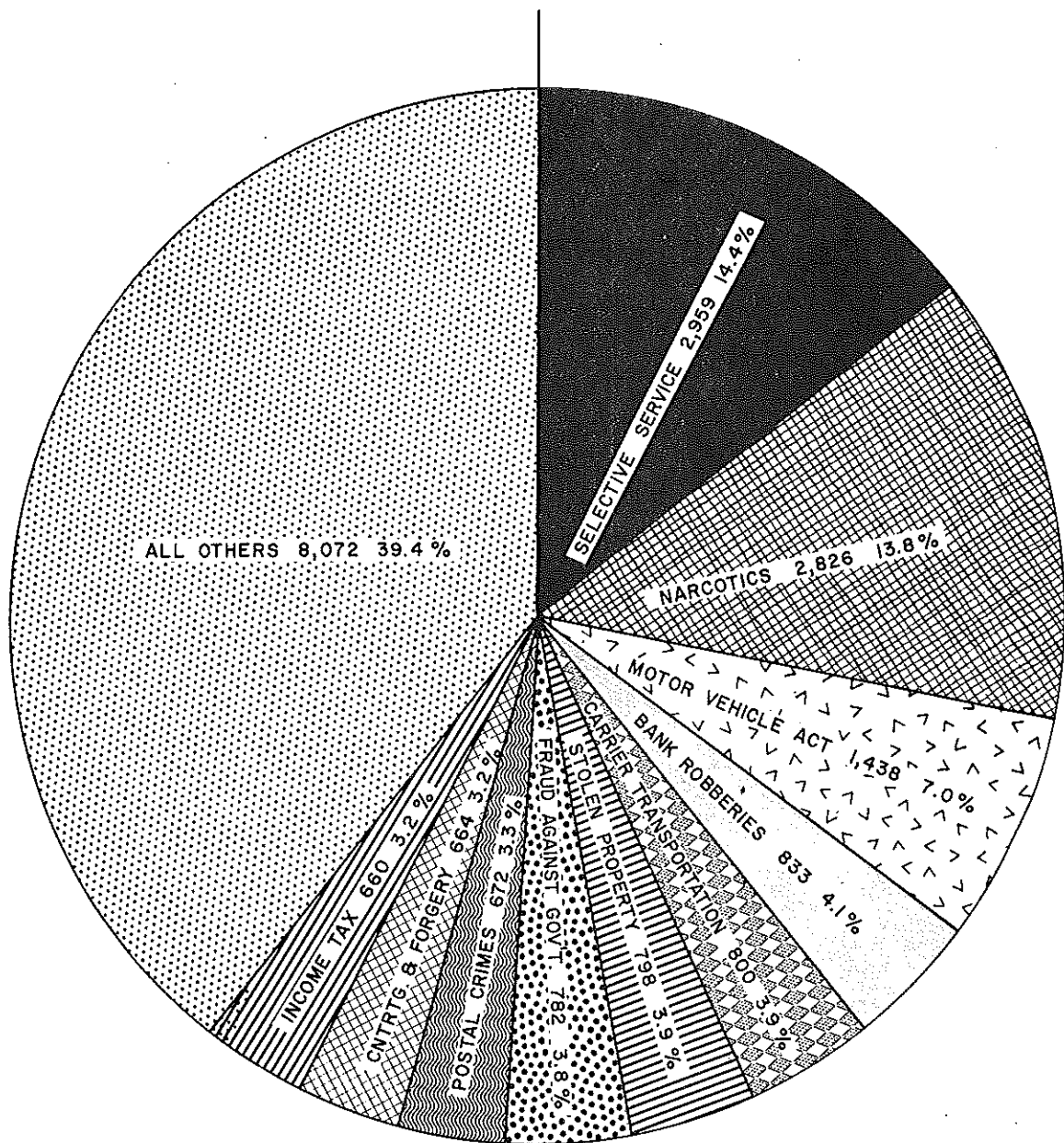

TOTAL 20,504 CASES

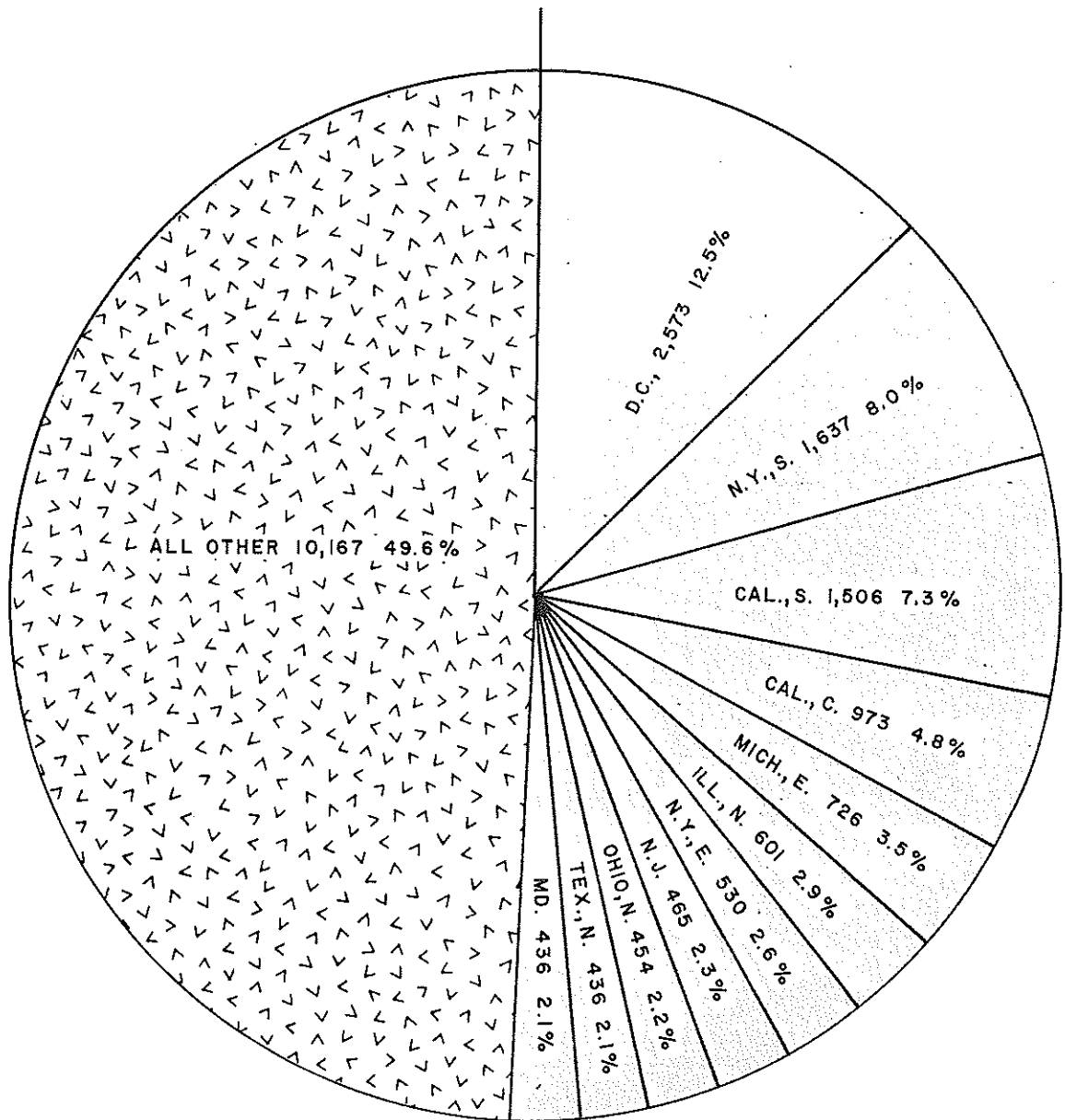

PROCEEDINGS BEFORE GRAND JURY IN UNITED STATES ATTORNEYS' OFFICES

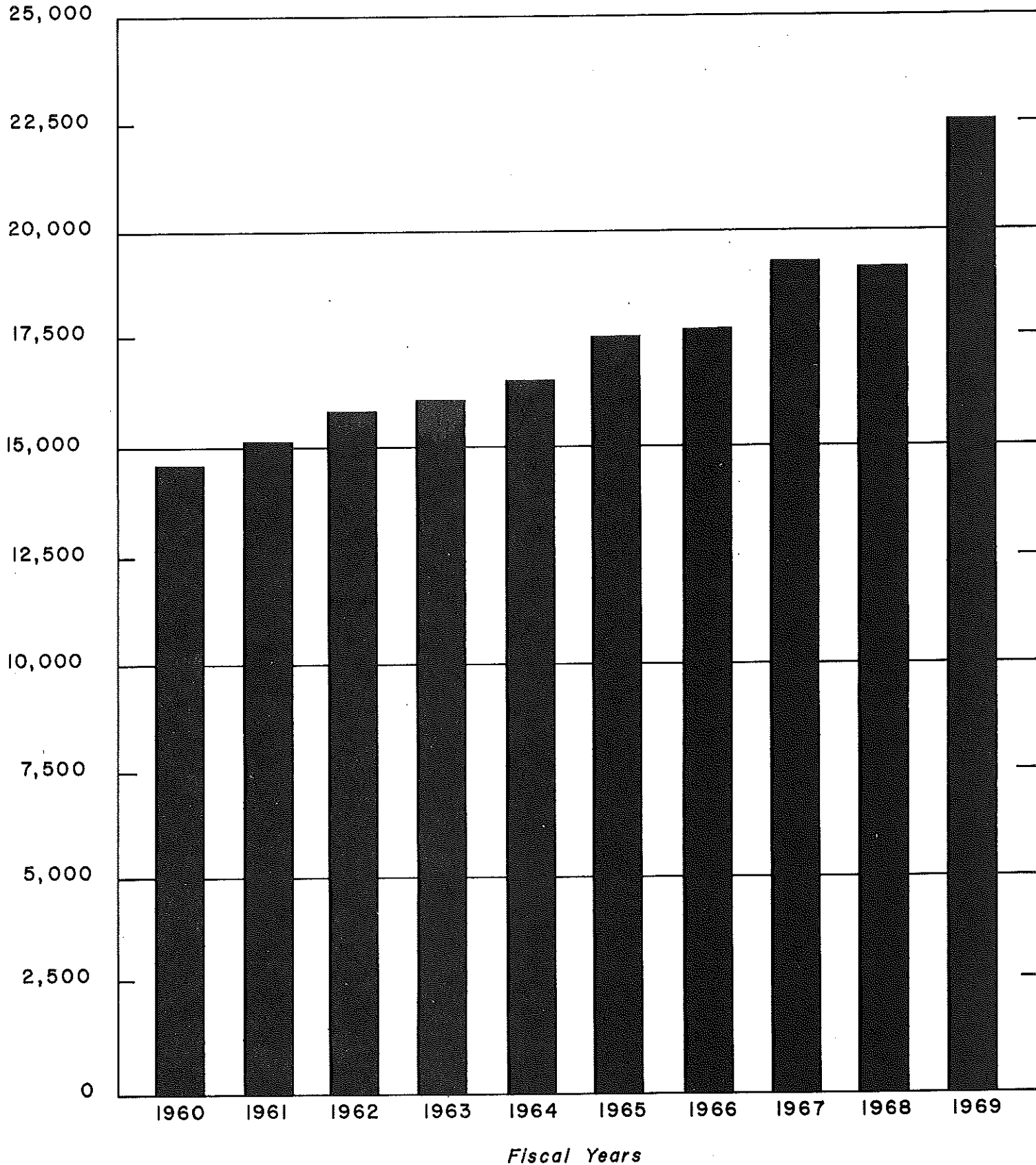

TOTAL CASES - CRIMINAL 20,504 CIVIL 23,245

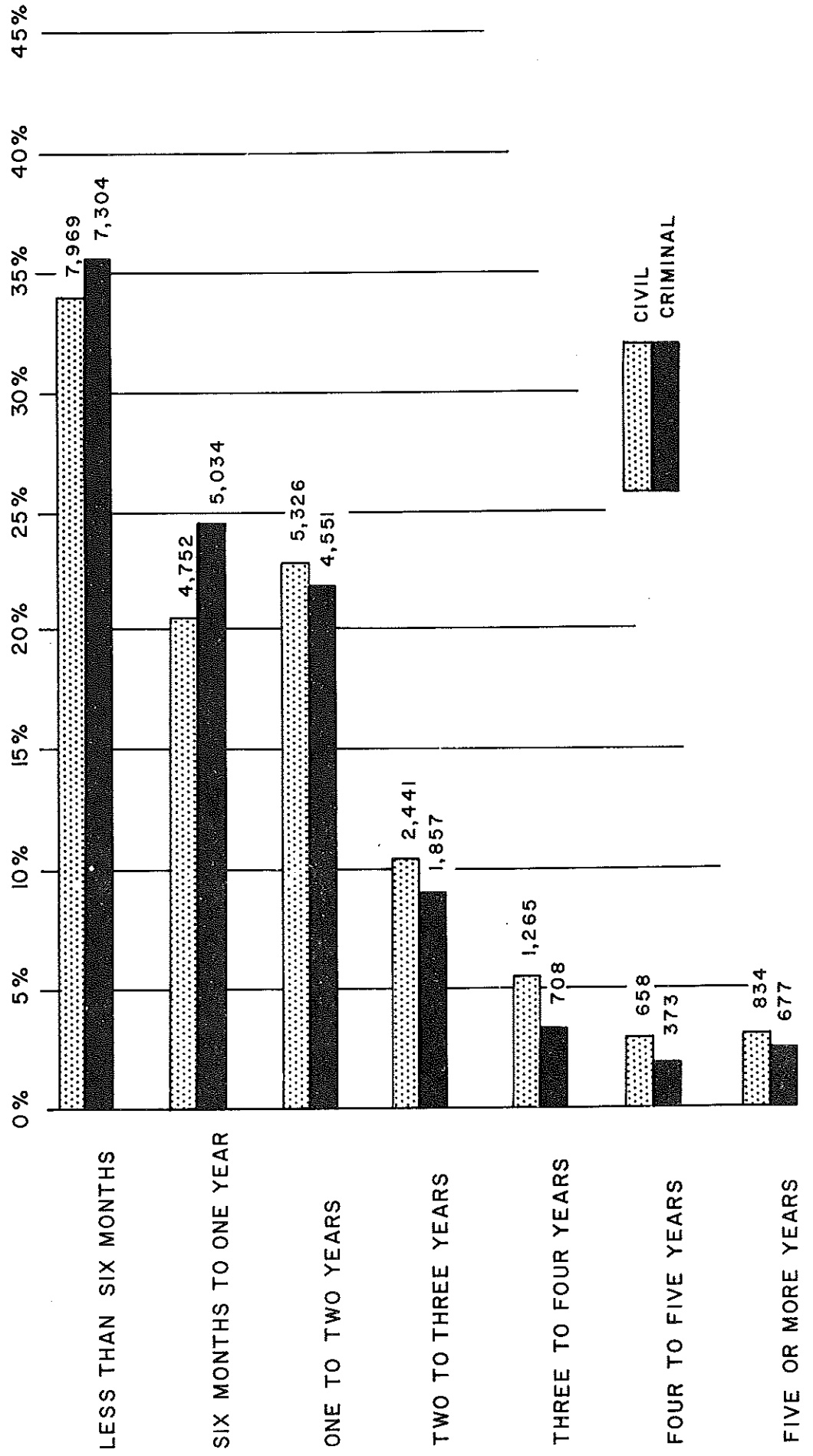

TOTAL 25,094 CASES

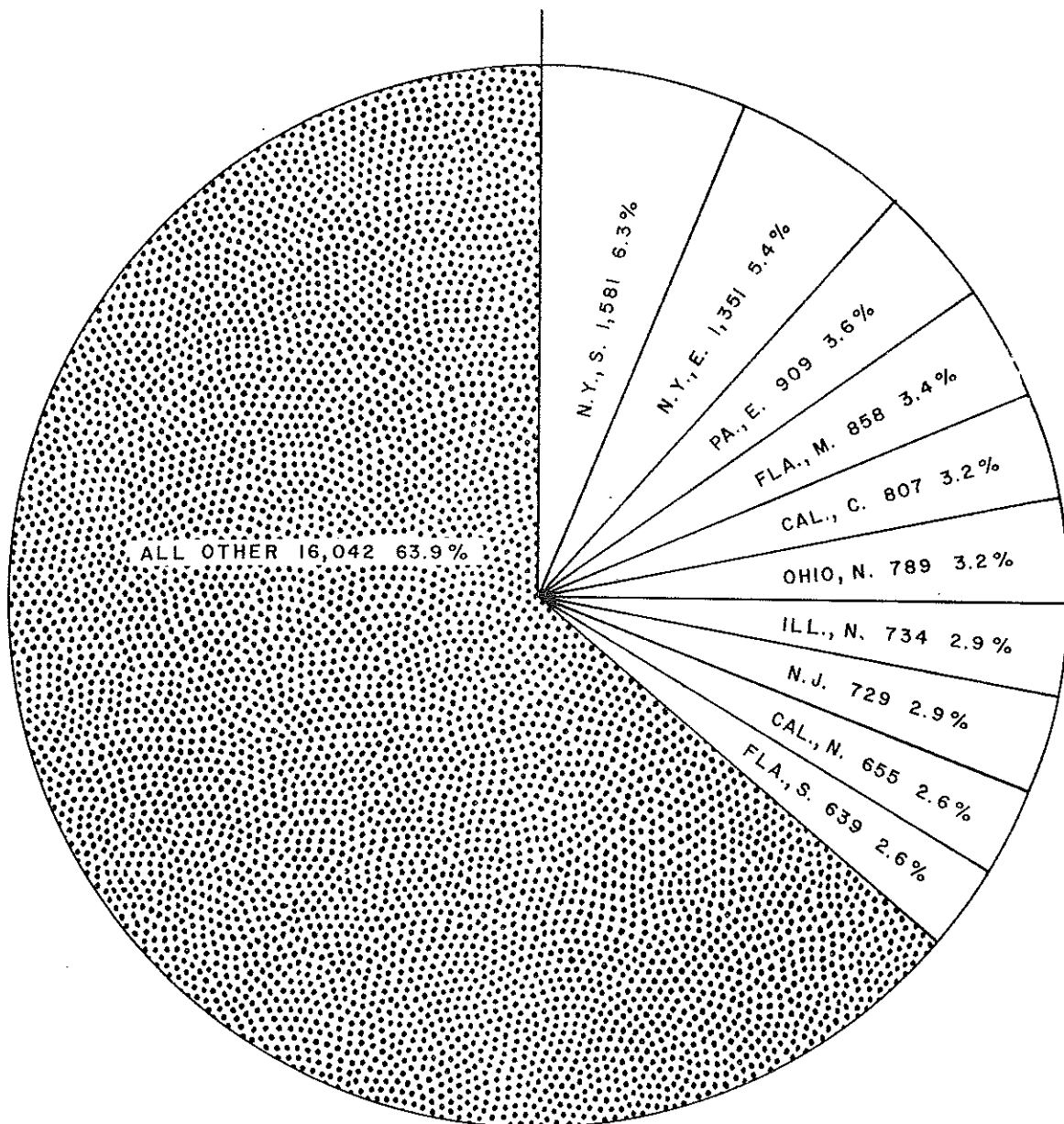
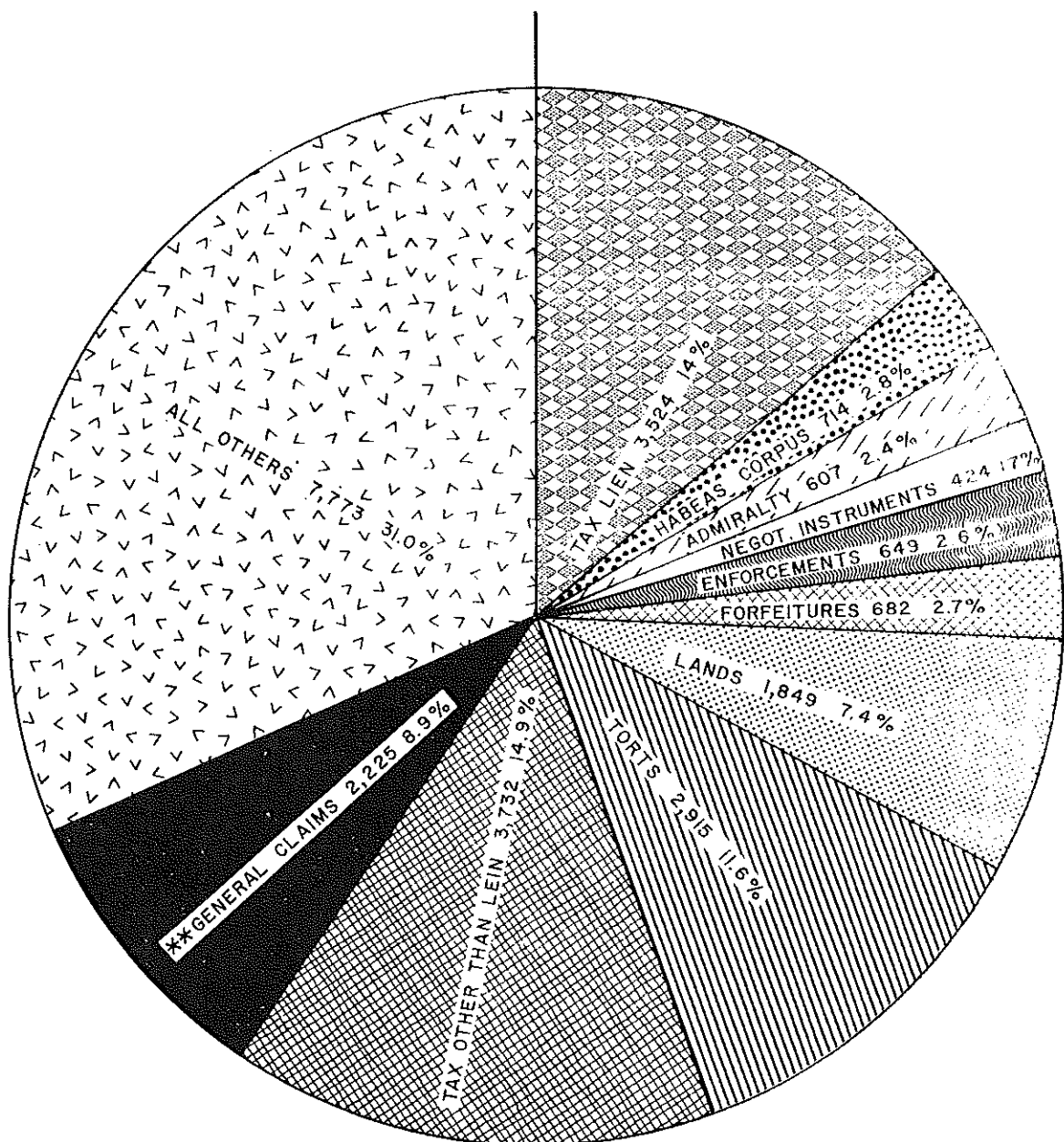


CHART NO. 12

IN UNITED STATES ATTORNEYS' OFFICES

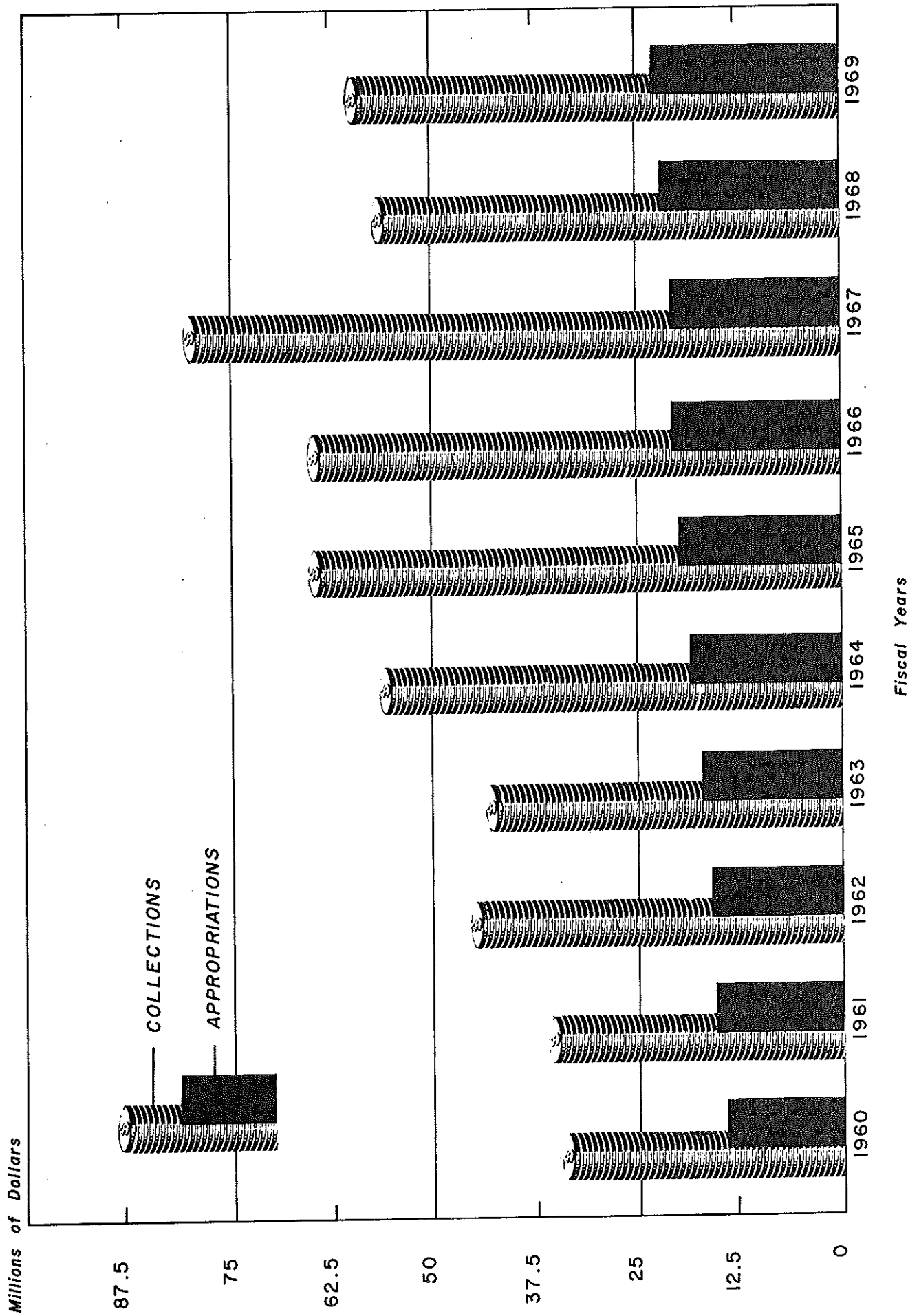
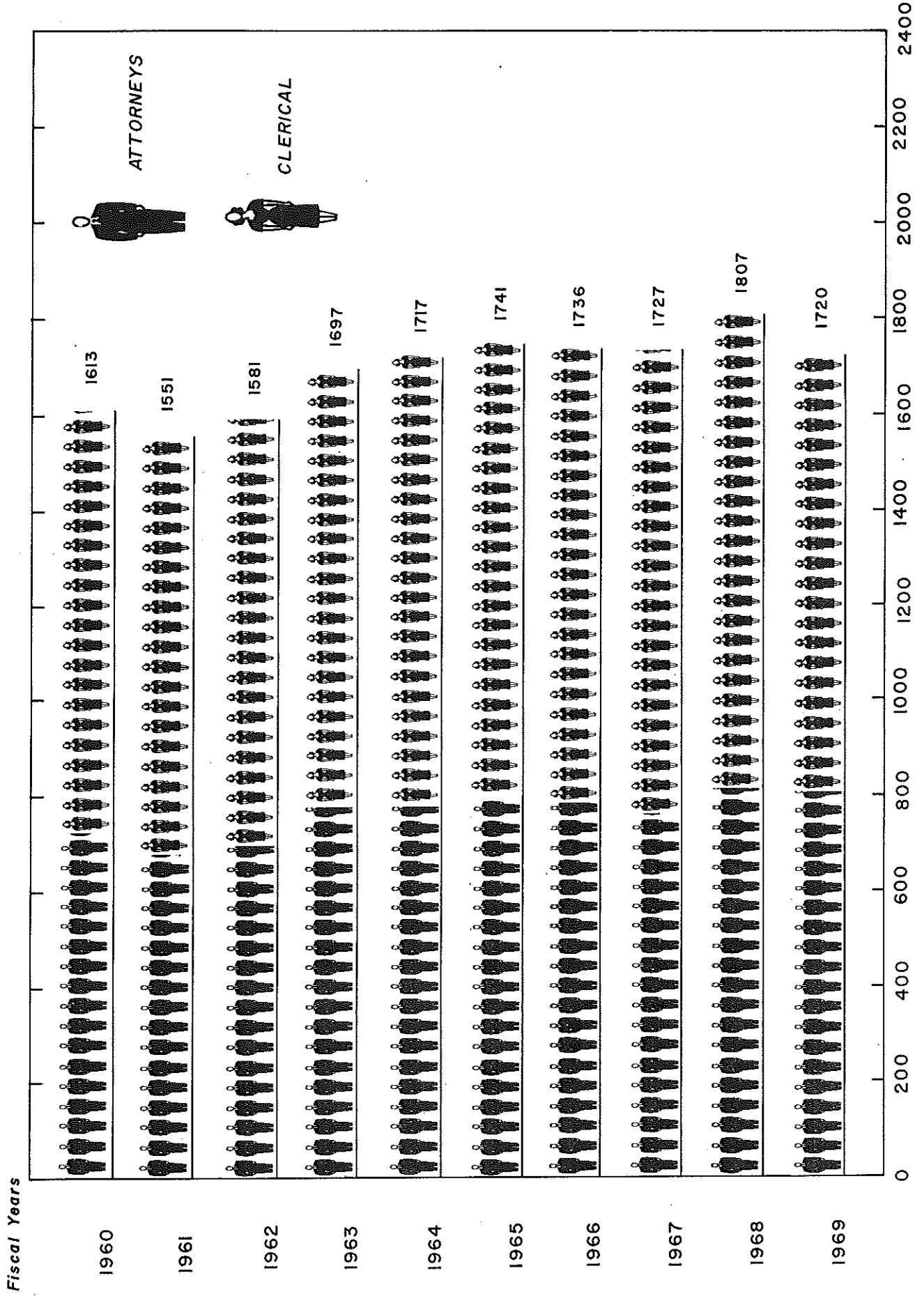
