### OIG Work Planning Process

OIG assesses relative risks in the programs for which it has oversight authority. OIG does so to identify areas most in need of attention and, accordingly, to set priorities for the sequence and proportion of resources to be allocated. This work plan identifies the projects, priorities, and initiatives that will support OIG's ability to achieve its strategic goals and objectives through Fiscal Year (FY) 2022 by the following:

- Providing independent products and services that promote integrity and positive change.
- Engaging stakeholders to conduct effective oversight and addressing Department and USAGM priorities and challenges.
- Strengthening OIG's workforce and internal operations.

Work planning is a dynamic process, and adjustments are made throughout the year to meet priorities and to anticipate and respond to emerging issues by utilizing the available resources. The projects and plans presented here are contingent upon availability of funds, budget decisions, and priorities and are, therefore, subject to revision.

#### WINTER INSPECTION CYCLE ADDENDUM TO THE FY 2021-2022 WORK PLAN

Typically, the Office of Inspections' (ISP) annual planning process results in a full fiscal year of scheduled inspections. However, ISP is planning inspections on a rolling basis due to uncertainties caused by the COVID-19 pandemic. ISP expects to announce its FY 2021 spring inspection schedule in January or February 2021. ISP will continue to assess evolving guidance related to the COVID-19 pandemic to plan for FY 2022 and beyond, as appropriate.

### Office of Inspections

The Office of Inspections (ISP) is comprised of multidisciplinary teams responsible for carrying out OIG's mandate to inspect overseas missions and domestic entities of the Department and USAGM. Inspections are conducted to provide the Department with independent assessments that cover three broad areas, consistent with Section 209 of the Foreign Service Act of 1980:

- Policy Implementation: whether policy goals and objectives are being effectively achieved, whether U.S. interests are being accurately and effectively represented, and whether all elements of an office or mission are being adequately coordinated.
- **Resource Management:** whether resources are being used and managed with maximum efficiency, effectiveness, and economy and whether financial transactions and accounts are properly conducted, maintained, and reported.
- Management Controls: whether the administration of activities and operations meets the requirements of applicable laws and regulations; whether internal management controls have been instituted to ensure quality of performance and reduce the likelihood of mismanagement; whether instances of fraud, waste, or abuse exist; and whether adequate steps for detection, correction, and prevention have been taken.

ISP reviews a variety of factors to create and implement a multi-tiered system for planning and conducting inspections. ISP seeks to target the Department's most significant vulnerabilities and to make its inspections as effective and efficient as possible. ISP's approach for planning overseas inspections incorporates factors that provide information on major functions at posts, including physical and information security, consular operations, and management platforms. In its inspection planning, ISP also considers the Department's major management and performance challenges:

- · Protection of people and facilities
- Oversight of contracts, grants, and foreign assistance
- · Information security and management
- · Financial and property management
- · Operating in contingency and critical environments
- Workforce management
- · Promoting accountability through internal coordination and clear lines of authority

The preliminary objectives for this inspection are to (1) assess whether the Grants Branch effectively manages Federal assistance awards while also meeting customer needs and requirements and (2) determine whether it has allocated its resources appropriately to address recent and proposed changes to its workload.

	A Bureau's Property Management Division (A/LM/PMP/PM) reviews program operations, implements regulations and procedures, and provides guidance in the areas of property receipt, storage, accountability, inventory management, utilization, and disposal. The division also develops and issues logistics policies for all Department personal property, including \$5.2 billion in nonexpendable property and \$91.1 million in expendable property worldwide in FY 2020. OIG inspection reports have found issues related to the management of property, including deficiencies related to expendable property accountability, warehousing operations, property transfers, residential inventories, and property disposals. The preliminary objective for this inspection is to assess A/LM/PMP/PM's effectiveness in implementing Department property management programs and internal controls. The inspection will include a review of several new programs aimed at enhancing post and	I

	A Bureau's Office of Overseas Schools (A/OPR/OS) assists posts in assessing the quality of overseas schools for the dependent children of U.S. Government employees. The office also supports programs to improve educational opportunities in countries where schools do not meet American educational standards. A/OPR/OS assists 192 overseas schools through direct and indirect support programs designed to promote an American-style education. The preliminary objectives for this inspection are to (1 determine whether A/OPR/OS effectively manages its resources, including \$12.5 million in grants, (2) assess the effectiveness of A/OPR/OS's support to overseas missions and schools, and (3) assess A/OPR/OS's support to overseas schools during the global COVID- 19 pandemic.

GTM/EX/SDD manages some of the Department's largest applications that impact its employees worldwide, including the Global Employment Management System, Overseas Personnel Systems, and HR Online. The preliminary objectives for this inspection are to assess whether GTM/EX/SDD (1) implemented standardized processes for system development life cycle management and (2) incorporated IT security requirements throughout the project life cycle of all major applications and general support system activities.

The branch receives leads from LSFIAs that require action overseas, as well as leads from RSOs and host nation investigative agencies requiring domestic follow up. DS/CR/CIL is often the only interface between DS and other agencies. The preliminary objectives for this investigation are to (1) assess DS/CR/CIL's response to investigative lead requests from LSFIAs and (2) determine whether the quality and timing of the responses meet the needs of the other investigative agencies.

	The Bureau of Educational and Cultural Affairs (ECA) oversees more than 140 exchange programs with an annual budget of nearly \$700 million. ECA's exchange programs bring more than 300,000 participants to the U.S. in a normal year. However, ECA announced the suspension or modification of a wide variety of these exchange programs in response to the COVID-19 pandemic. The preliminary objectives of this information report are to assess the effects of the COVID-19 pandemic on ECA in three areas: (1) financia management and budget expenditures for FY 2021; (2) impact on the bureau's key implementing partners and mitigating steps undertaken by ECA in this regard; and (3) ECA's ability to carry out activities under existing awards, meet performance goals, and ensure adequate monitoring and evaluation of programs.	1

### Office of Overseas Contingency Operations Oversight

OIG has joint responsibility to oversee current and future overseas contingency operations (OCOs) under Section 8L of the IG Act, which provides for designation of a lead inspector general (Lead IG) for each OCO from among the inspectors general of the Department of Defense (DoD), the Department, and the U.S. Agency for International Development (USAID).

OIG's Office of Overseas Contingency Operations Oversight collaborates with DoD and USAID Offices of Inspector General, and coordinates OCO oversight planning and execution within OIG to fulfill joint Lead IG responsibilities. As of October 2020, there are two OCOs requiring Lead IG oversight: Operation Inherent Resolve to defeat the Islamic State of Iraq and Syria (ISIS) in those two nations and Operation Freedom's Sentinel to train, advise, and assist Afghan security forces and conduct counterterrorism missions against the remnants of al-Qaeda, ISIS, and other terrorist groups in Afghanistan. Lead IG activities in support of each OCO include (1) joint strategic planning to provide comprehensive oversight of all OCO-related programs and operations; (2) program management to track, monitor, and update OCO-related information; and (3) collaboration to collect and analyze interagency information and prepare quarterly reports for Congress on the whole-of-government effort in support of each OCO.

The three Offices of Inspector General conduct joint and individual audits, inspections, evaluations, and investigations to provide independent, effective oversight of all programs and operations of the U.S. Government that support each OCO. OIG also inspects leadership, policy implementation, and resource management at overseas embassies and domestic bureaus related to OIG's Lead IG oversight mandate.

Specific projects planned for the FY 2021 winter inspection cycle in support of OIG's OCO oversight mission are, to the extent permissible in an unclassified setting, listed in the table below. The listed projects are described in more detail in the preceding pages of this addendum.
